



**(QUEEN STREET, ALVA)
(TEMPORARY CLOSURES) ORDER 2016**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Queen Street, Alva) (Temporary Closures) Order 2016" and notwithstanding the date hereof shall come into operation on the 1st June 2016.

2. The effect of this Order shall be to close to vehicles:-
 The period from 1900 hours on Tuesday 14th June 2016 until 1200 hours on Wednesday 15th June 2016. From 1900 hours on Tuesday 21st June 2016 until 1200 hours on Wednesday 22nd June 2016. From 1900 hours on Tuesday 28th June 2016 until 1200 hours on Wednesday 29th June 2016 on the section described in the Schedule attached. The temporary closures are required for safety reasons and to bring in modular buildings and park these overnight before being off loaded by crane.
