The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (B9096 Alloa to Tullibody) (Temporary Footway Closure) Order 2016" and notwithstanding the date hereof shall come into operation on the 15<sup>th</sup> June 2016.
2. The effect of this Order shall be to close to pedestrians:-  
The period from 0800 hours on Wednesday 29<sup>th</sup> June 2016 for a period of 7 weeks or until completion on the section described in the Schedule attached. The temporary closure is required to widen the footway as part of the Tullibody to Cambus Active Travel Route.

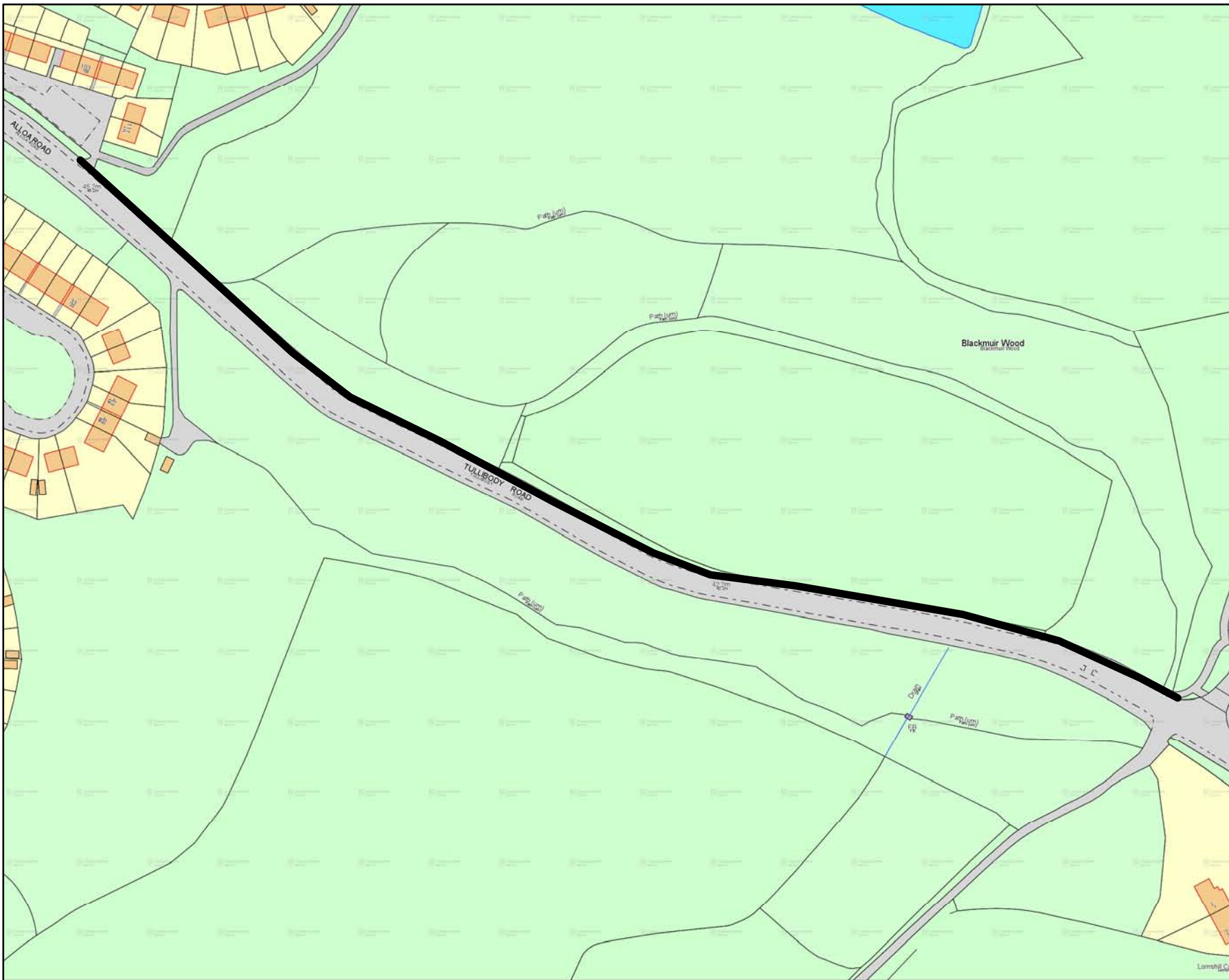
