



**(HIGH STREET AND MILL STREET, ALLOA)
(TEMPORARY CLOSURE) ORDER 2016**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (High Street and Mill Street, Alloa) (Temporary Closure) Order 2016" and notwithstanding the date hereof shall come into operation on the 22nd June 2016.
2. The effect of this Order shall be to close to vehicles:-
The period from 0900 hours until 1700 hours on all of the following Sundays: 3rd, 10th, 17th, 24th, 31st July 2016 and 7th, 14th, 21st, 28th August 2016 on the section described in the Schedule attached. The temporary closure is required for lining works to be carried out when dry.

The Council has made "The Clackmannanshire Council (High Street and Mill Street, Alloa) (Temporary Closure) Order 2016", under the Road Traffic Regulation Act 1984 (as amended) on 22nd June 2016: to close to vehicles at **High Street, Alloa** from its junction with Drysdale Street to its junction with Mill Street, a distance of 130 metres or thereby, and at **Mill Street, Alloa** from its junction with Mar Street until its junction with Shillinghill, a distance of 126 metres or thereby. The order runs from 0900 hours until 1700 hours on all of the following Sundays: 3rd, 10th, 17th, 24th, 31st July 2016 and 7th, 14th, 21st, 28th August 2016, and is required for lining works to be carried out when dry. 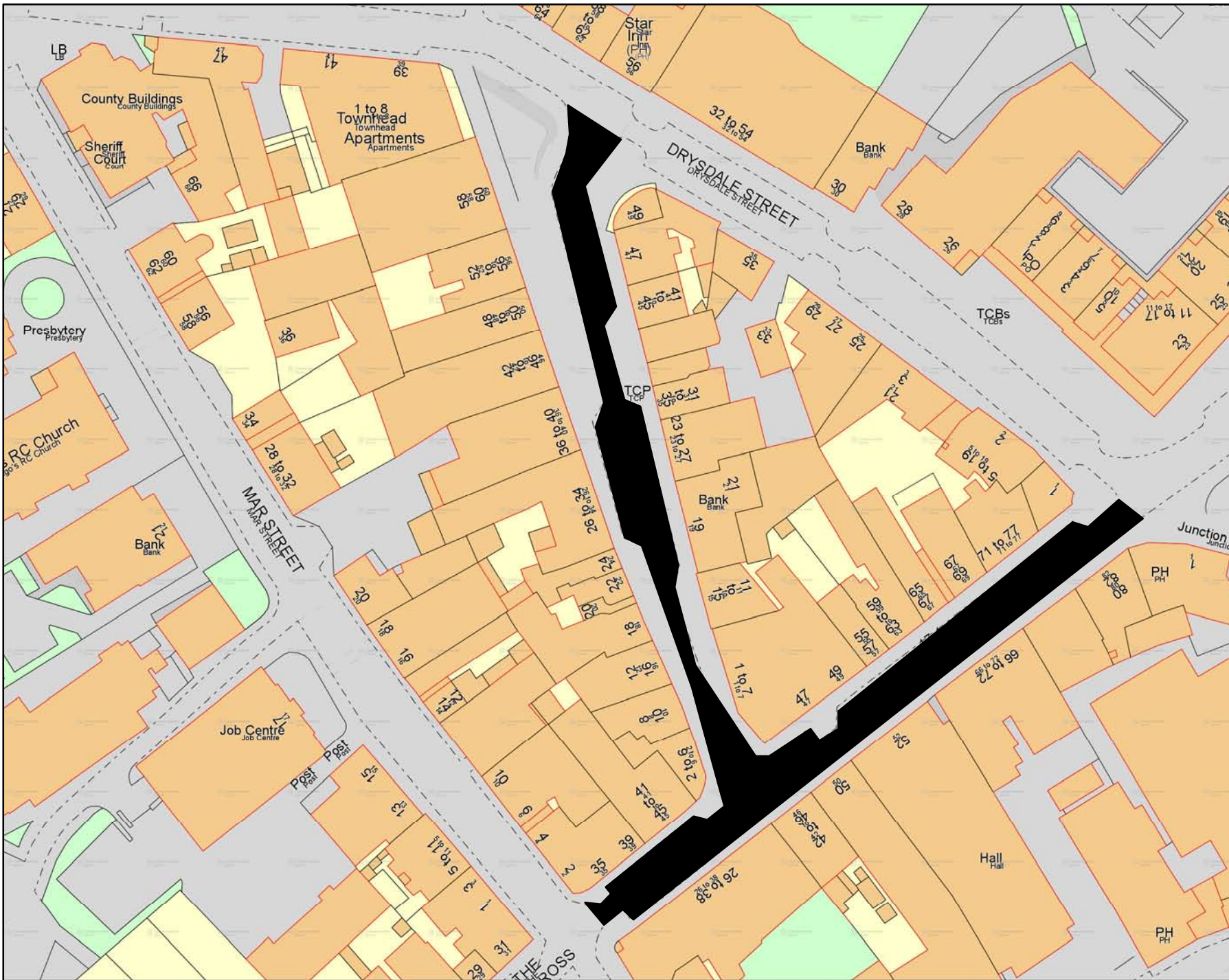
