1. This Order may be cited as "The Clackmannanshire Council (A907 Claremont, Alloa) (Temporary Revocation of One Way) Order 2016" and notwithstanding the date hereof shall come into operation on the 11th August 2016.
2. The effect of this Order shall be to revoke the one way:-  
The period from 0800 hours on Saturday 27th August 2016 until 1900 hours on Sunday 28th August 2016 on the section described in the Schedule attached. The temporary revocation of one way is required to keep access for residents at Tulligarth Park during resurfacing works.

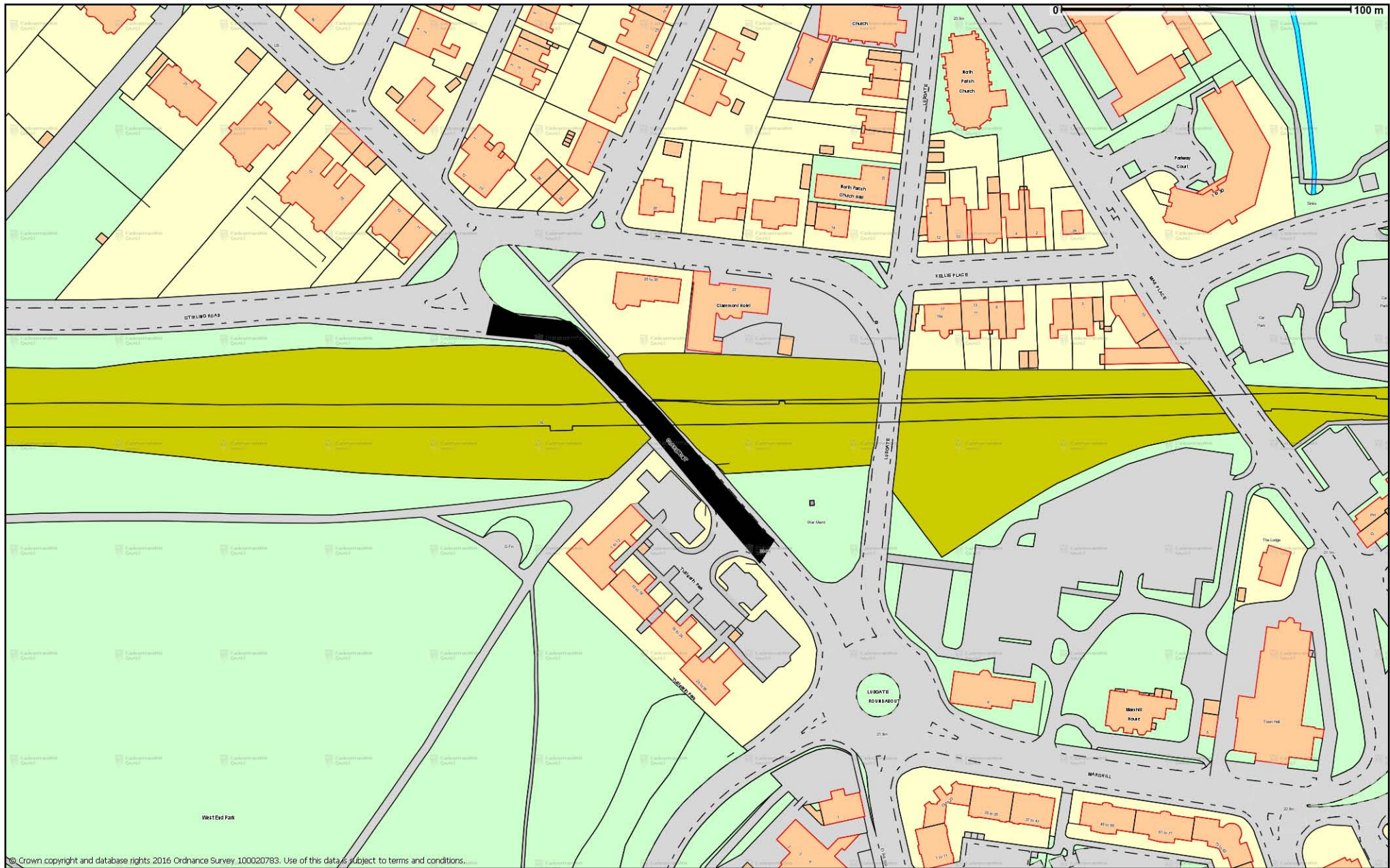
