## (VARIOUS STREETS, ALLOA) (TEMPORARY REVERSAL OF ONE WAY) ORDER 2016

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Reversal of One Way) Order 2016" and notwithstanding the date hereof shall come into operation on the 23<sup>rd</sup> August 2016.
- 2. The effect of this Order shall be to temporarily reverse the one way traffic system:-The period from 0600 hours until 1900 hours on Sunday 4<sup>th</sup> September 2016 and Sunday 11<sup>th</sup> September 2016 on the section described in the Schedule attached. The temporary reversal of one way is required to accommodate traffic during the closure of Marshill Roundabout.

# The Clackmannanshire Council (Various Streets, Alloa) (Temporary Reversal of One Way) Order 2016

The Council has made "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Reversal of One Way) Order 2016", under the Road Traffic Regulation Act 1984 (as amended) on 23<sup>rd</sup> August 2016: to temporarily reverse the one way traffic system at **Mar Street, Alloa** – one-way north to south for its entirety, and at **Mill Street, Alloa** – one-way west to east from its junction with Mar Street westwards to its junction with High Street, a distance of 35 metres or thereby. The order runs from 0600 hours until 1900 hours on Sunday 4<sup>th</sup> September 2016 and Sunday 11<sup>th</sup> September 2016 and is required to accommodate traffic during the closure of Marshill Roundabout.
