



**(DRYSDALE STREET, ALLOA)
(TEMPORARY CLOSURE) ORDER 2016**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Drysdale Street, Alloa) (Temporary Closure) Order 2016" and notwithstanding the date hereof shall come into operation on the 20th September 2016.

2. The effect of this Order shall be to close to vehicles:-
The period from 0600 hours until 1900 hours on Sunday 9th October 2016 and Sunday 16th October 2016 on the section described in the Schedule attached. The temporary closure is required for resurfacing works.

3. This Order revokes "The Clackmannanshire Council (Drysdale Street, Alloa) Order 2016" (Ref: 5/6/1389) as the dates for the temporary closure have changed.

(Diversion: Via Marshall, Ludgate, Bedford Place, Bank Street, Mill Street, Mar Street). The order runs from 0600 hours until 1900 hours on Sunday 9th October 2016 and Sunday 16th October 2016 and is required for resurfacing works. 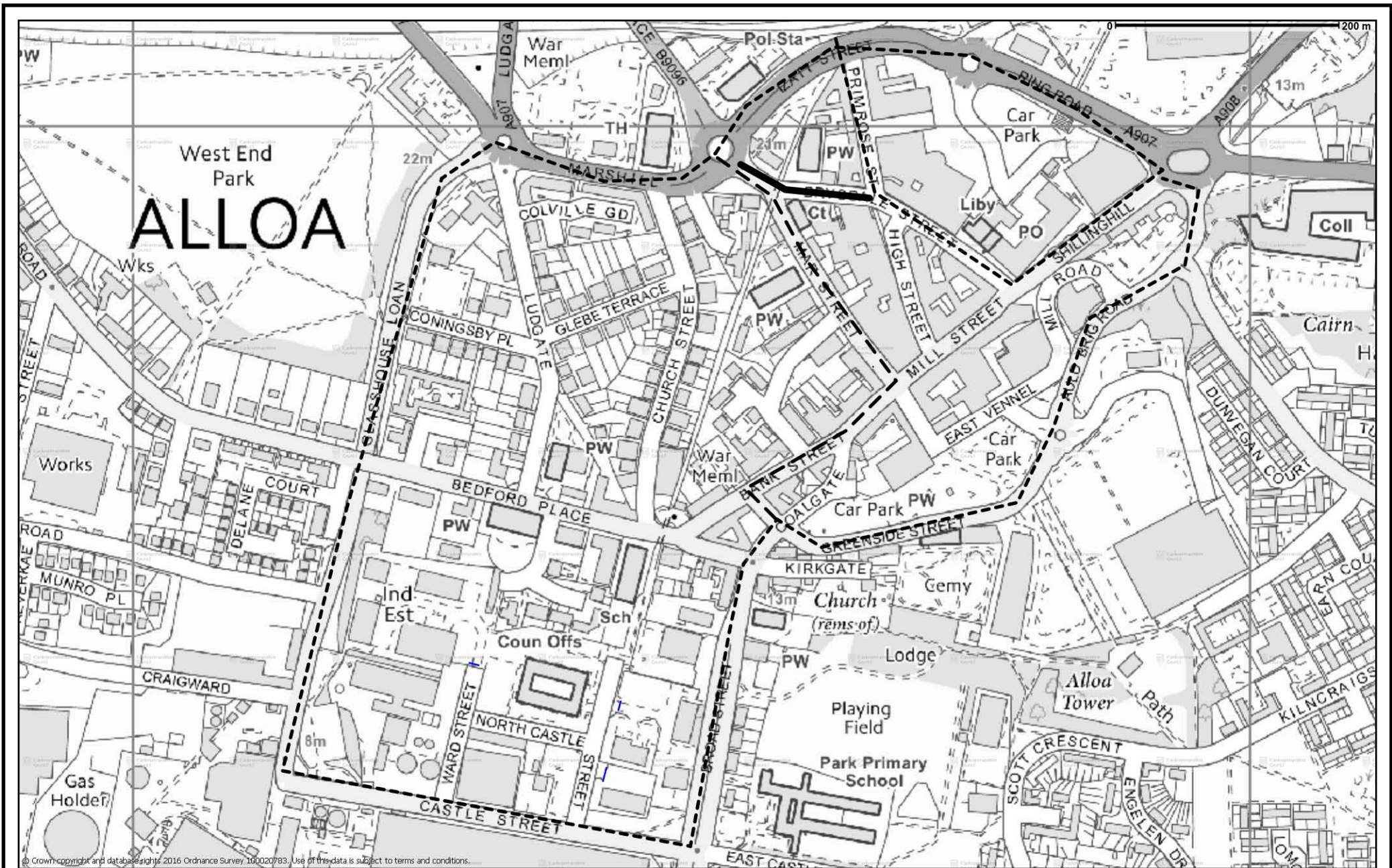
