



**(GRANGE ROAD, ALLOA)
(TEMPORARY CLOSURE) ORDER 2016**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Grange Road, Alloa) (Temporary Closure) Order 2016" and notwithstanding the date hereof shall come into operation on the 27th September 2016.
2. The effect of this Order shall be to close to vehicles:-
The period from 1700 until 2100 hours on Saturday 5th November 2016 on the section described in the Schedule attached. The temporary closure is necessary for public safety during the Fireworks display. Access will be maintained for residents, buses, emergency services and pedestrians.

The Council has made "The Clackmannanshire Council (Grange Road, Alloa) (Temporary Closure) Order 2016", under the Road Traffic Regulation Act 1984 (as amended) on 27th September 2016: to close to vehicles at Grange Road, Alloa from its junction with Ludgate westwards until its junction with Grant Street, a distance of 485 metres or thereby. (Diversion Route: Via Grant Street, Caledonian Road, Glasshouse Loan, Ludgate and vice versa). Access will be maintained for residents, buses, emergency services and pedestrians. The order runs from 1700 hours until 2100 hours on 5th November 2016 and is necessary for public safety during the Fireworks display. 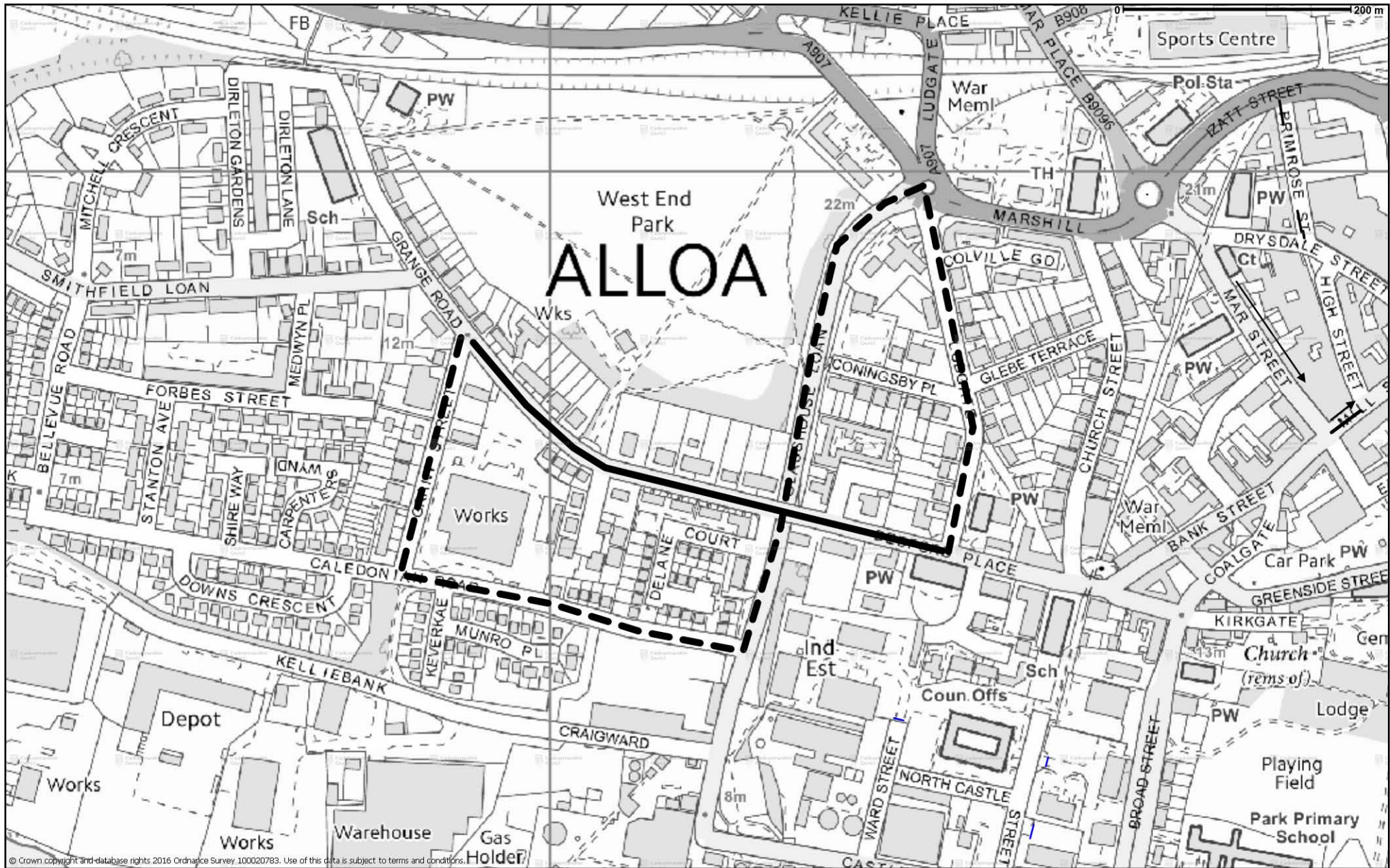
