



**(LUDGATE, ALLOA)
(TEMPORARY CLOSURE) ORDER 2016**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Ludgate, Alloa) (Temporary Closure) Order 2016" and notwithstanding the date hereof shall come into operation on the 27th September 2016.
2. The effect of this Order shall be to close to vehicles:-
The period from 0800 hours on Friday 14th October 2016 until 1800 hours on Saturday 15th October 2016 on the section described in the Schedule attached. The temporary closure is necessary for BT/MUS carrying out emergency Network Works.

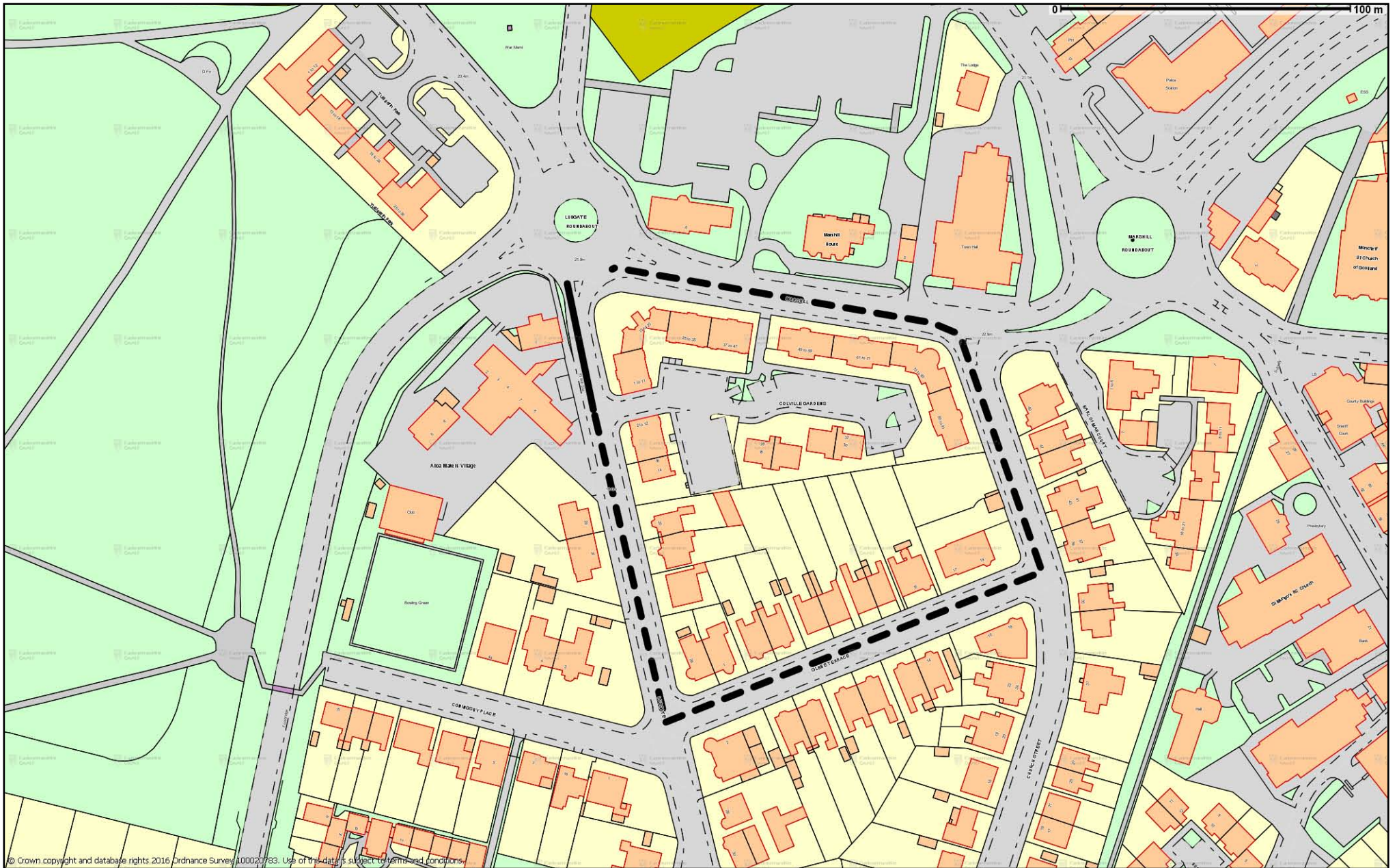
