

# (PRIMROSE STREET, ALLOA) (TEMPORARY NO PARKING) ORDER 2016

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (Primrose Street, Alloa) (Temporary No Parking) Order 2016" and notwithstanding the date hereof shall come into operation on the 18<sup>th</sup> October 2016.
- 2. The effect of this Order shall be to put in place a no parking restriction:-The period from 0600 hours until 1900 hours on Sunday 30<sup>th</sup> October 2016 on the section described in the Schedule attached. The temporary no parking restriction is required to make sure buses can make the turn at either end of Primrose Street during the closure of Drysdale Street, Alloa.

The Council has made "The Clackmannanshire Council (Primrose Street, Alloa ) (Temporary No Parking) Order 2016", under the Road Traffic Regulation Act 1984 (as amended) on 18<sup>th</sup> October 2016: to put in place a no parking restriction at **Primrose Street, Alloa (West Side)** from its junction with A907 southwards for a distance of 25 metres or thereby, and **Primrose Street, Alloa (West Side)** from its junction with Drysdale Street northwards for a distance of 25 metres or thereby. The order runs from 0600 hours until 1900 hours on Sunday 30<sup>th</sup> October 2016 and is required to make sure buses can make the turn at either end of Primrose Street during the closure of Drysdale Street, Alloa.
