



**(VARIOUS STREETS, ALVA)  
(TEMPORARY CLOSURE) ORDER 2016**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alva) (Temporary Closure) Order 2016" and notwithstanding the date hereof shall come into operation on the 28<sup>th</sup> October 2016.
2. The effect of this Order shall be to close to vehicles:-  
The period from 1140 hours until 1155 hours on Sunday 13<sup>th</sup> November 2016 on the section described in the Schedule attached. The temporary closure is required to assist Police Scotland in their powers to hold traffic for the Alva Remembrance Parade.

### **The Clackmannanshire Council (Various Streets, Alva) (Temporary Closure) Order 2016**

The Council has made "The Clackmannanshire Council (Various Streets, Alva) (Temporary Closure) Order 2016", under the Road Traffic Regulation Act 1984 (as amended) on 28<sup>th</sup> October 2016: to close to vehicles at **A91, Stirling Street, Alva** from a point outside Alva Parish Church westwards until its junction with Copland Place, a distance of 210 metres or thereby; and at **Copland Place, Alva** for its entirety, a distance of 72 metres or thereby. The order runs from 1140 hours until 1155 hours on Sunday 13<sup>th</sup> November 2016 and is required to assist Police Scotland in their powers to hold traffic for the Alva Remembrance Parade. 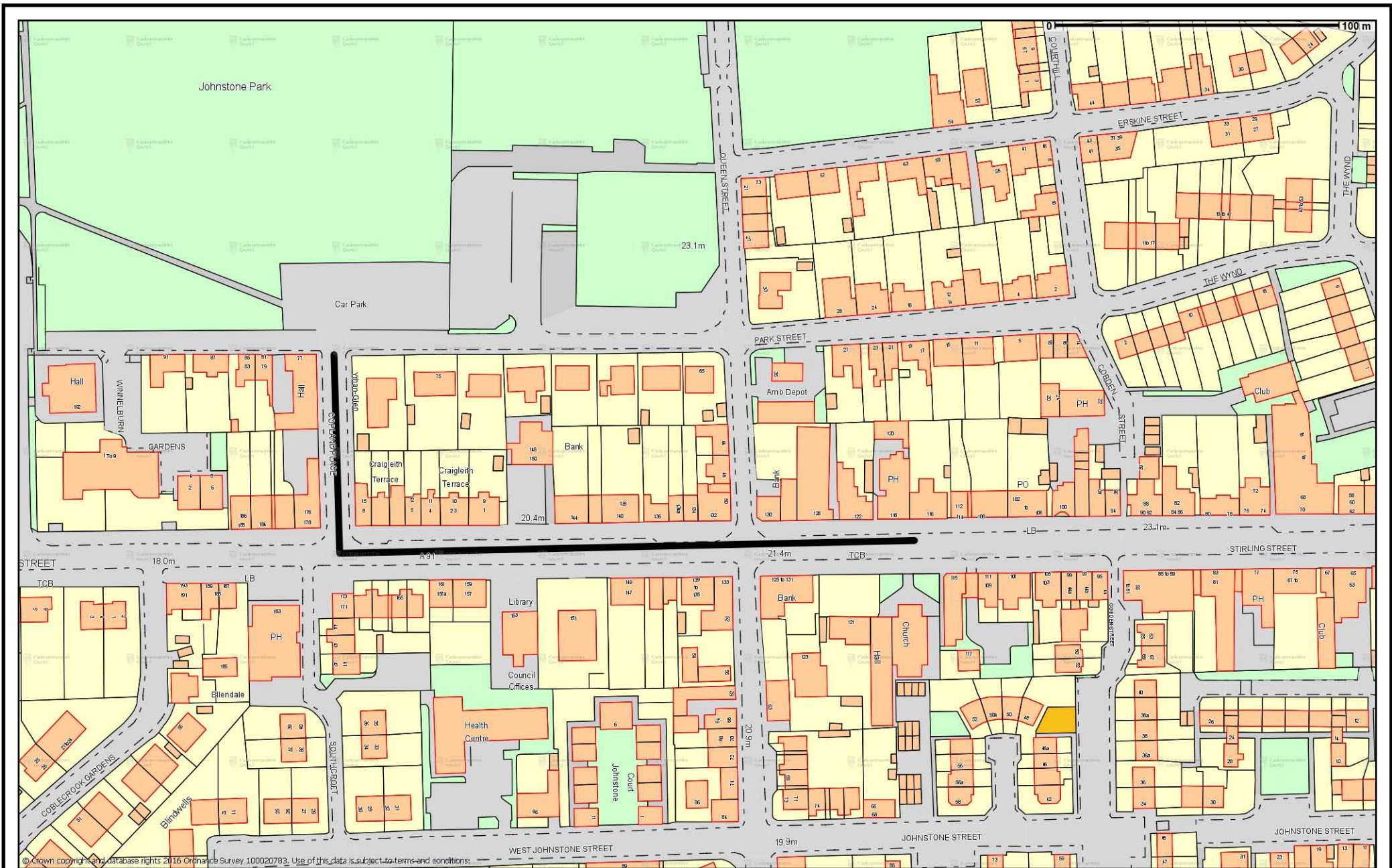
