



**(KING STREET, ALLOA)
(TEMPORARY CLOSURE) ORDER 2016**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (King Street, Alloa) (Temporary Closure) Order 2016" and notwithstanding the date hereof shall come into operation on the 9th November 2016.

2. The effect of this Order shall be to close to vehicles:-
The period from 1900 hours on Saturday 19th November 2016 until 0600 hours on Monday 21st November 2016, on the section described in the Schedule attached. The temporary closure is required for a new sewer connection for the development.

The order runs from 1900 hours on Saturday 19th November 2016 until 0600 hours on Monday 21st November 2016, and is required for a new sewer connection for the development. 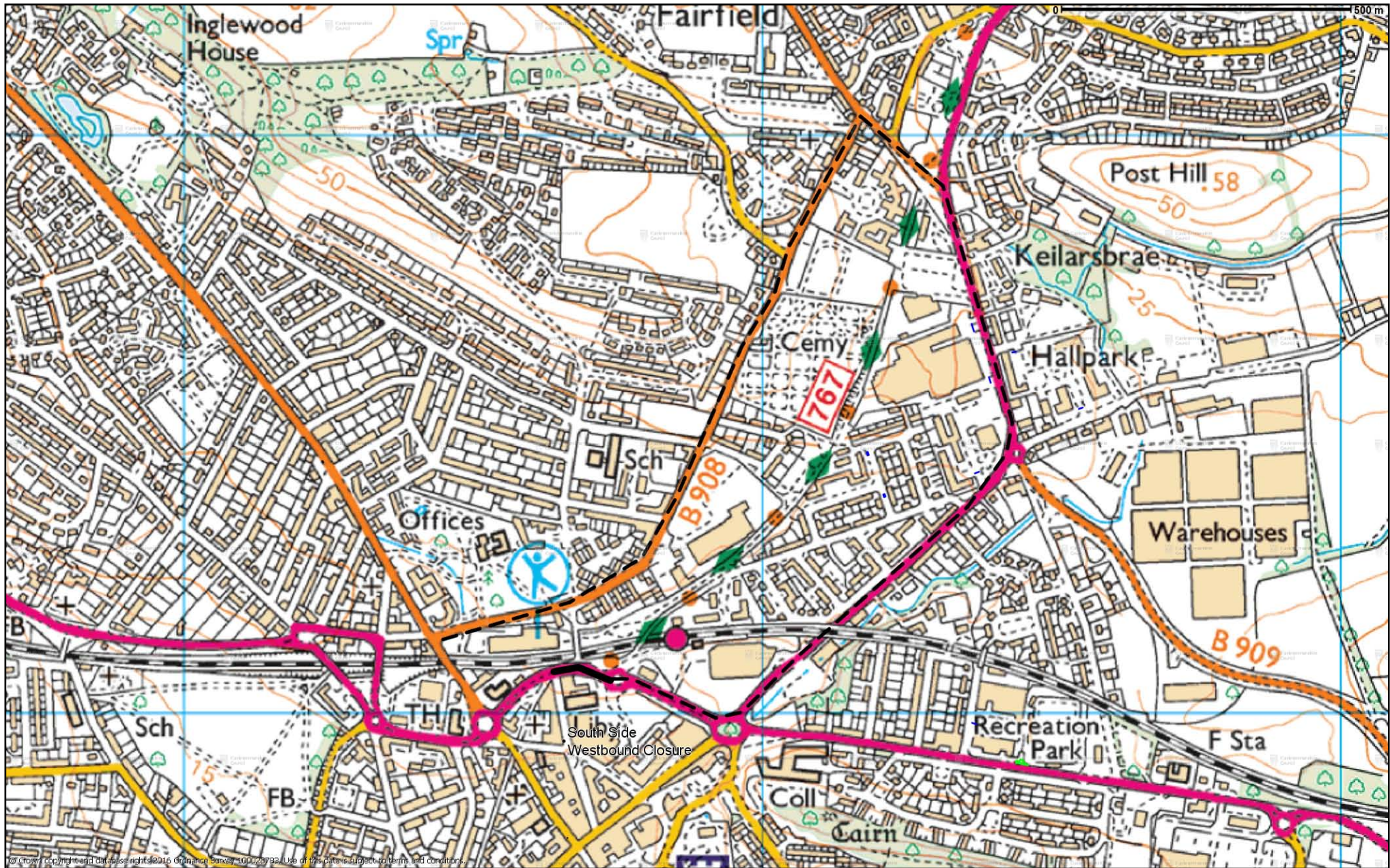
