



**(HENDERSON AVENUE, ALLOA)
(TEMPORARY ROAD CLOSURE) ORDER 2017**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Henderson Avenue, Alloa) (Temporary Road Closure) Order 2017" and notwithstanding the date hereof shall come into operation on the 26th January 2017.

2. The effect of this Order shall be to close to vehicles:-
The period from 0800 hours on Monday 20th February 2017 for a period of 5 days or until works are completed whichever is soonest, on the section described in the Schedule attached. The temporary closure is necessary during roadworks as 3 way lights will be in operation.

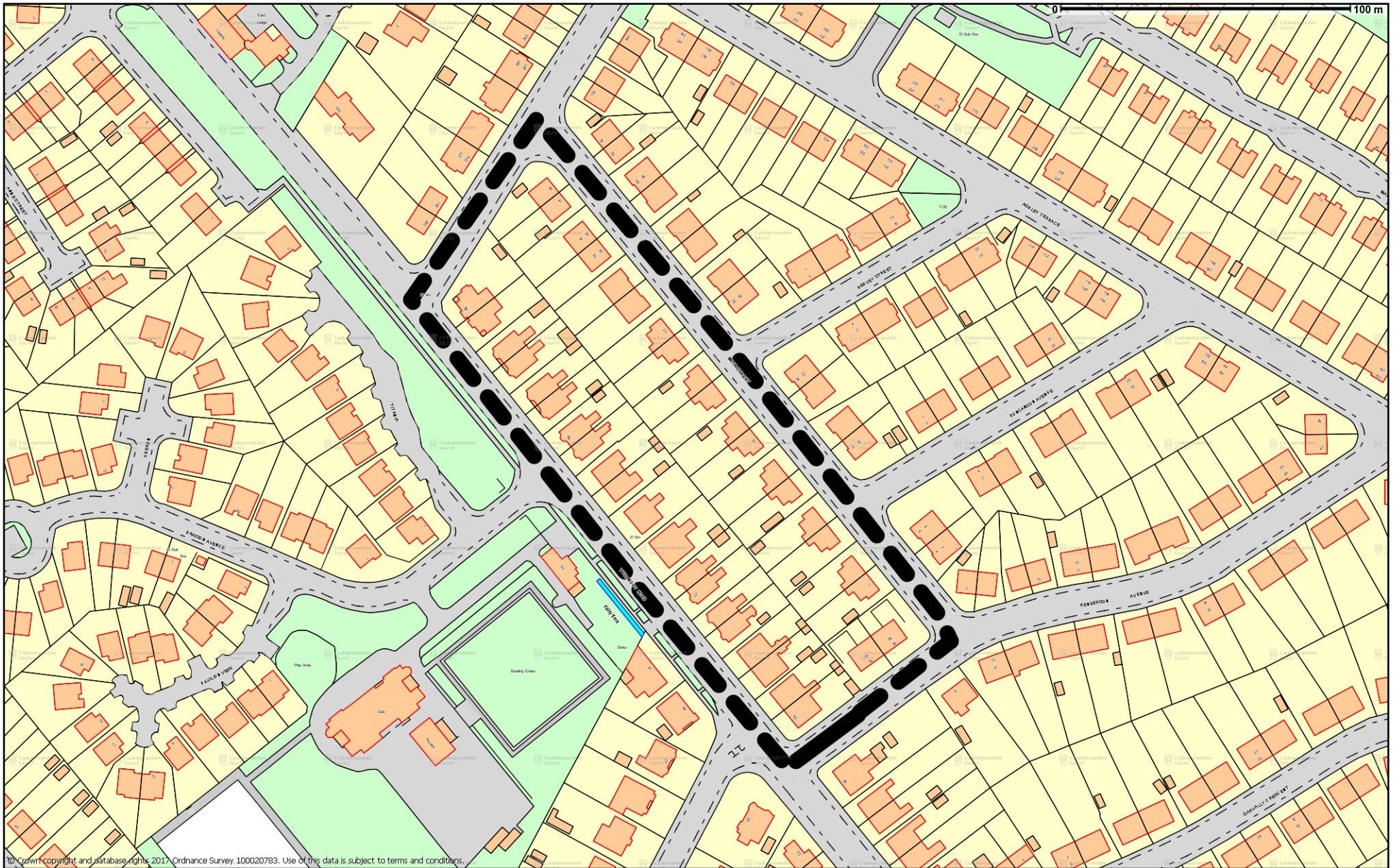
