# (VARIOUS STREETS, ALLOA) (TEMPORARY PARKING SUPENSION) ORDER 2017

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Parking Suspension) Order 2017" and notwithstanding the date hereof shall come into operation on the 26<sup>th</sup> January 2017.
- 2. The effect of this Order shall be to suspend parking:-The period from 0730 hours until 1800 hours each day from Monday 20<sup>th</sup> February 2017 for a period of 5 days or until works are completed whichever is soonest on the section described in the Schedule attached. The temporary parking suspension is necessary to keep traffic moving during roadworks as 3 way traffic lights will be in operation.

The Council has made "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Parking Suspension) Order 2017", under the Road Traffic Regulation Act 1984 (as amended) on 26<sup>th</sup> January 2017: to suspend parking at **Victoria Street, Alloa** on both sides - from its junction with B9096 Tullibody Road, southwards until its junction with Claremont, a distance of 280 metres or thereby, and at **Alexandra Drive, Alloa on the** East Side from its junction with Claremont, southwards until its junction with A907 Stirling Road, a distance of 220 metres of thereby. The order runs from 0730 hours until 1800 hours each day from Monday 20<sup>th</sup> February 2017 for a period of 5 days or until works completed whichever is soonest. The order is necessary to keep traffic moving during roadworks as 3 way traffic lights will be in operation.
