



**(A907 CLACKMANNAN BYPASS)
(TEMPORARY SPEED RESTRICTION) ORDER 2017**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (A907 Clackmannan Bypass) (Temporary Speed Restriction) Order 2017" and notwithstanding the date hereof shall come into operation on the 7th February 2017.

2. The effect of this Order shall be to reduce the speed limit to 40 MPH:-
 During the period from 0800 hours on Monday 13th March 2017 until Friday 27 September 2019 or until works are completed whichever is soonest, on the section described in the Schedule attached. The temporary speed restriction is necessary to allow construction access into a residential development, but will only have effect in relation to such part of parts of the lengths of road as are indicated by the appropriate traffic signs and during the periods corresponding to those lengths or road specified in the Schedule to this Notice.

The Clackmannanshire Council (A907 Clackmannan Bypass) (Temporary Speed Restriction) Order 2017

The Council has made "The Clackmannanshire Council (A907 Clackmannan Bypass) (Temporary Speed Restriction) Order 2017", under the Road Traffic Regulation Act 1984 (as amended) on 7th February 2017: to reduce the speed limit to 40mph on the **A907 Clackmannan Bypass** from a point 90 metres east of Helensfield junction at the national speed limit sign eastwards for a distance of 820 metres or thereby. The order runs from 0800 hours on Monday 13th March 2017 until Friday 27th September 2019 or until works are completed, whichever is soonest. The order is necessary to allow construction access into a residential development, but will only have effect in relation to such part or parts of the lengths of road as are indicated by the appropriate traffic signs and during the periods corresponding to those lengths of road specified in the Schedule to this Notice. 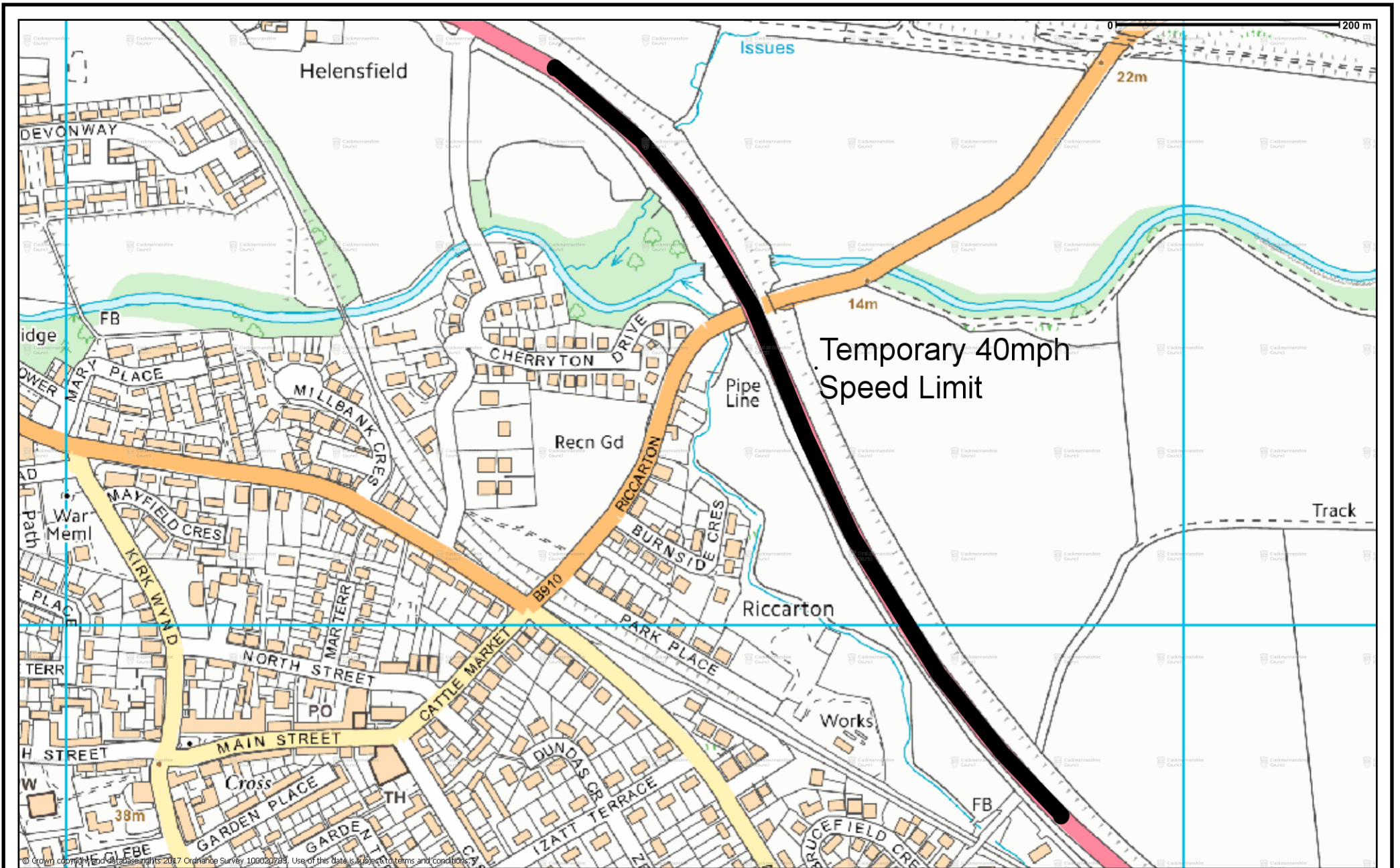
