- 1. This Order may be cited as "The Clackmannanshire Council (Brook Street, Alva) (Temporary Road Closure) Order 2017" and notwithstanding the date hereof shall come into operation on the 9<sup>th</sup> March 2017.
- 2. The effect of this Order shall be to close to vehicles:-The period from 0800 hours on Monday 3<sup>rd</sup> April 2017 until 1530 hours on Wednesday 5<sup>th</sup> April 2017, on the section described in the Schedule attached. The temporary closure is necessary for safety of workforce during carriageway resurfacing works and kerbing works.
