(TEMPORARY FOOTWAY CLOSURE) ORDER 2017**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (King Street, Alloa) (Temporary Footway Closure) Order 2017" and notwithstanding the date hereof shall come into operation on the 14<sup>th</sup> March 2017.
  
2. The effect of this Order shall be to close to vehicles:-  
The period from 0800 hours on Monday 3<sup>rd</sup> April 2017 for a period of 3 weeks or until works are completed whichever is soonest, on the section described in the Schedule attached. The temporary footway closure is necessary to install new gas infrastructure within the footpath.

### **The Clackmannanshire Council (King Street, Alloa) (Temporary Footway Closure) Order 2017**

The Council has made "The Clackmannanshire Council (King Street, Alloa) (Temporary Footway Closure) Order 2017", under the Road Traffic Regulation Act 1984 (as amended) on 14<sup>th</sup> March 2017: to close to pedestrians at **King Street, Alloa (South Side)** from a point 34 metres or thereby east of its junction with Primrose Street, eastwards for a distance of 100 metres of thereby. The order runs from 0800 hours on Monday 3<sup>rd</sup> April 2017 for a period of 3 weeks or until works are completed whichever is soonest, and is necessary to install new gas infrastructure within the footpath.
