

(VARIOUS STREETS, ALVA) (TEMPORARY ROAD CLOSURE) ORDER 2017

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alva) (Temporary Road Closure) Order 2017" and notwithstanding the date hereof shall come into operation at 1140 hours on the 27th May 2017 and will remain in operation until 1205 hours on that day.
- 2. The effect of this Order shall be to close to vehicles:-The period from 1140 hours until 1205 hours on Saturday 27th May 2017, on the section described in Schedule attached. The temporary closure is required to facilitate a procession for the Alva Community Fun Day Superhero Parade. The rolling road closure will assist Police Scotland in their duties.


