## (VARIOUS STREETS, ALLOA) (TEMPORARY ROAD CLOSURE) ORDER 2017

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Road Closure) Order 2017" and notwithstanding the date hereof shall come into operation at 0930 hours on the 31<sup>st</sup> May 2017 and will remain in operation until 1130 hours on that day.
- 2. The effect of this Order shall be to close to vehicles:-

The period from 0930 hours until 1130 hours on Wednesday, 31st May 2017 on the section described in Schedule A, and the period from 1000 hours until 1020 hours on Wednesday, 31st May 2017 on the section described in Schedule B. The temporary closure is necessary to facilitate Armed Forces Day.

#### The Clackmannanshire Council (Various Streets, Alloa) (Temporary Road Closure) Order 2017

The Council has made "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Road Closure) Order 2017", under the Road Traffic Regulation Act 1984 (as amended) on 3rd May 2017. The effect of this Order shall be to close to vehicles: - Schedule A: to close to vehicles at the A907 - Marshill, Alloa from its junction with the Marshill Roundabout for a distance of 170 metres or thereby in a westerly direction to its junction with Ludgate Roundabout. (Alternative Route: East Bound Traffic - Via Ludgate, Bedford Place, Bank Street, Union Street, Greenside Street and Auld Brig Road to the A907 Shillinghill Roundabout and West Bound Traffic - Via the B9096 Tullibody Road to its junctions with the A907 at Dumyat Park Roundabout). Also to close to vehicles at Church Street, Alloa from its junction with the Marshill Roundabout to its junction with Glebe Terrace, a distance of 75 metres or thereby. (Alternative Route: No alternative route). Schedule B: to close to vehicles at Drysdale Street, Alloa from its junction with the Marshill Roundabout until its junction with Shillinghill, a distance of 288 metres or thereby. (Alternative Route: No alternative route). Also to close to vehicles at Primrose Street, Alloa from its junction with the Ring Road southwards until its junction with Drysdale Street, a distance of 124 metres or thereby. (Alternative Route: No alternative route). The order runs from 0930 hours until 1130 hours on Wednesday 31<sup>st</sup> May 2017 on the section described in Schedule A, and from 1000 hours until 1020 hours on Wednesday, 31<sup>st</sup> May 2017 on the section described in Schedule B, and is necessary to facilitate Armed Forces Day.
