1. This Order may be cited as "The Clackmannanshire Council (Main Street, Sauchie) (Temporary Road Closure) Order 2017" and notwithstanding the date hereof shall come into operation at 1230 hours on 4th June 2017 and will remain in operation until 1630 hours on that date.

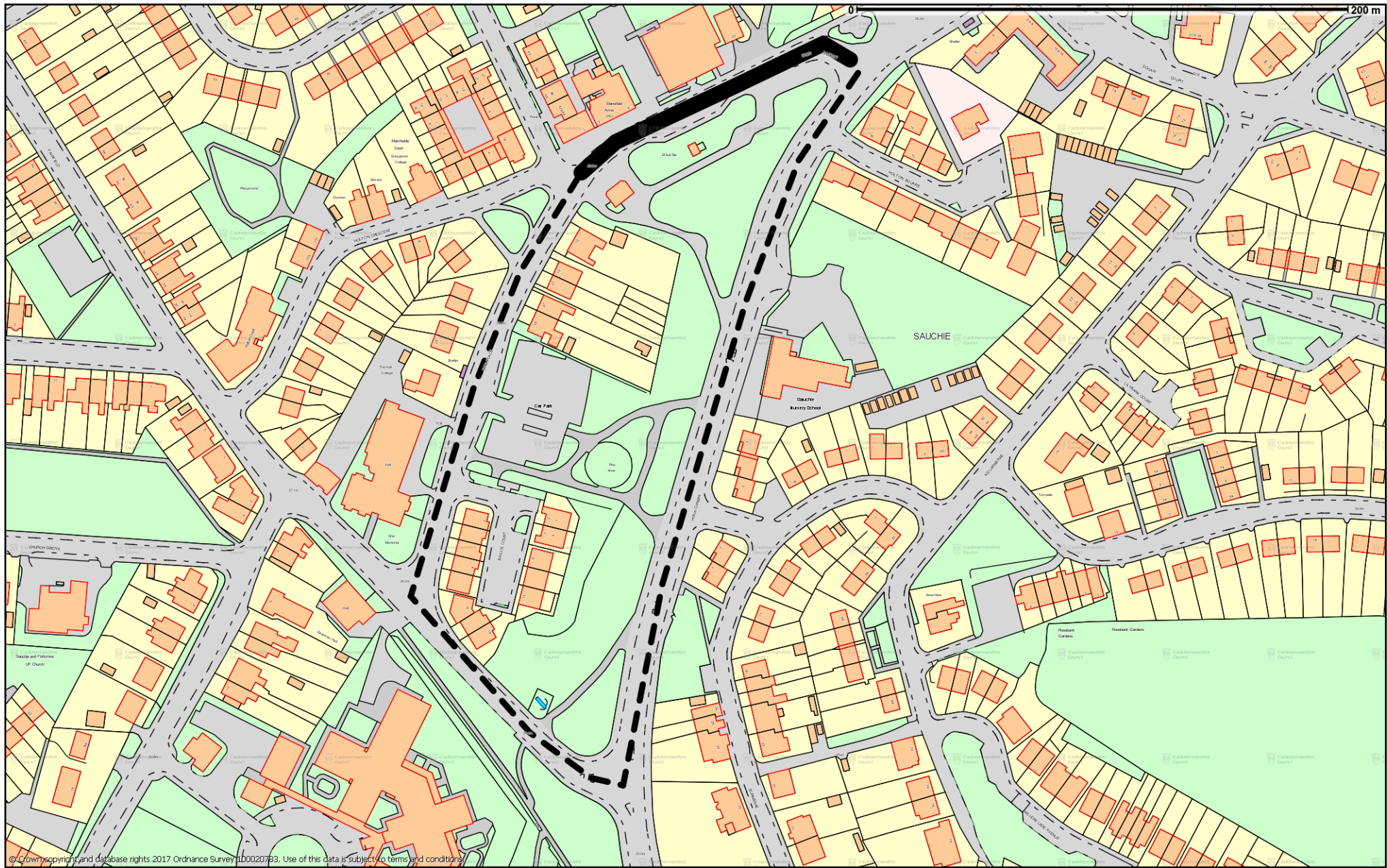
