



**(VARIOUS STREETS, ALLOA)
(TEMPORARY ROAD CLOSURE) ORDER 2017**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Road Closure) Order 2017" and notwithstanding the date hereof shall come into operation at 2130 hours on 8th June 2017 and will remain in operation until 0001 hours on 9th June 2017.

2. The effect of this Order shall be to close to vehicles:-
The period from 2130 hours on Thursday 8th June 2017 until 0001 hours on Friday 9th June 2017, on the section described in Schedule attached. The temporary closure is necessary for security reasons during the Elections.

Diversion – Via Ludgate, Bedford Place, Bank Street, Greenside Street, Auld Brig Road, King Street and vice versa. 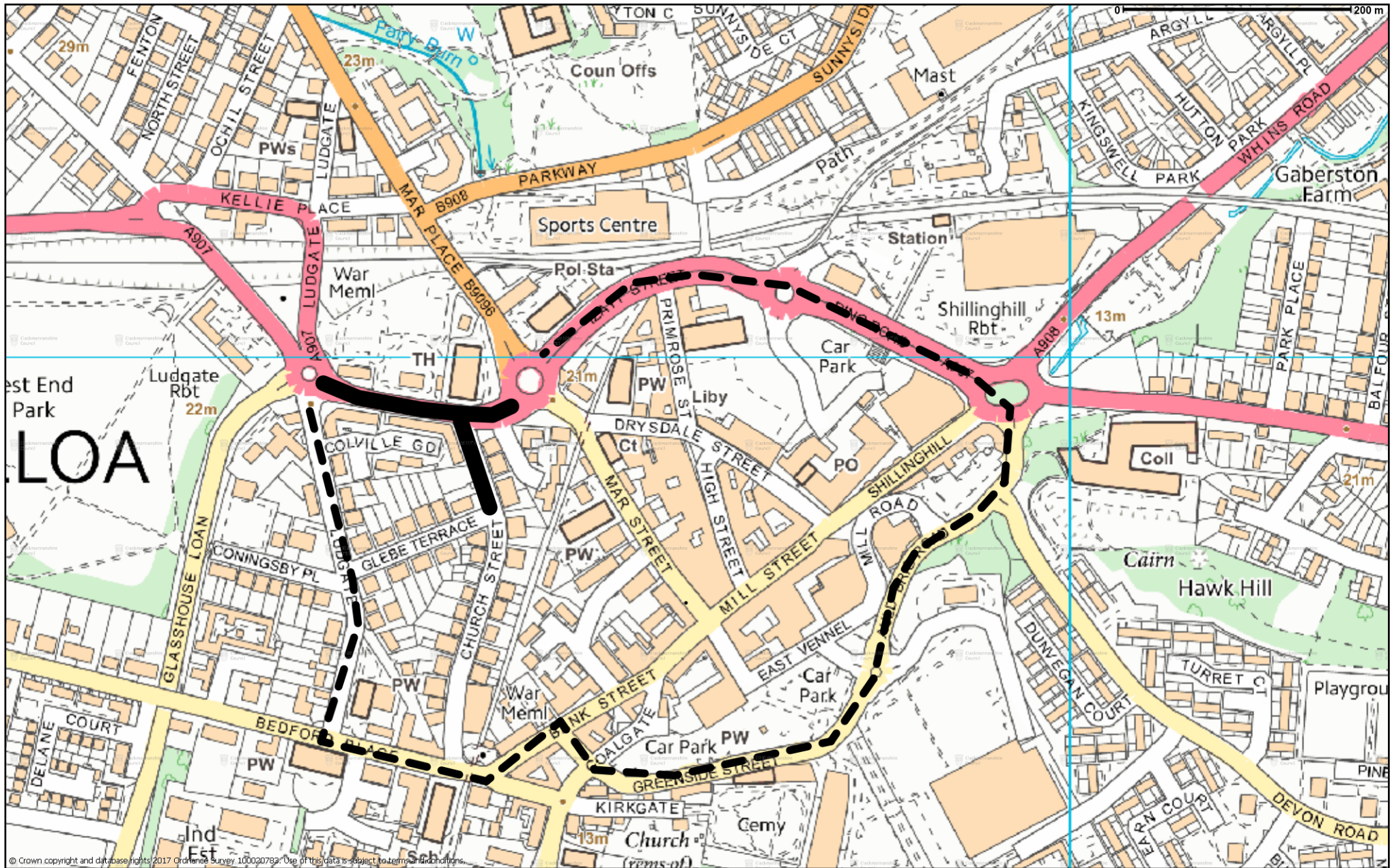
