



**(VARIOUS STREETS, ALLOA)
(TEMPORARY ROAD CLOSURE) (PART 3) ORDER 2017**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Road Closure) (Part 3) Order 2017" and notwithstanding the date hereof shall come into operation at 1230 hours on Saturday 8th July 2017 and will remain in operation until 1730 hours on that day (or open as soon as parade has passed).
2. The effect of this Order shall be to close to vehicles:-

The period from 1230 hours until 1730 hours on Saturday 8th July 2017 (or open as soon as parade has passed) on the section described in Schedule 3. The temporary closure is required to facilitate a large parade within Alloa.

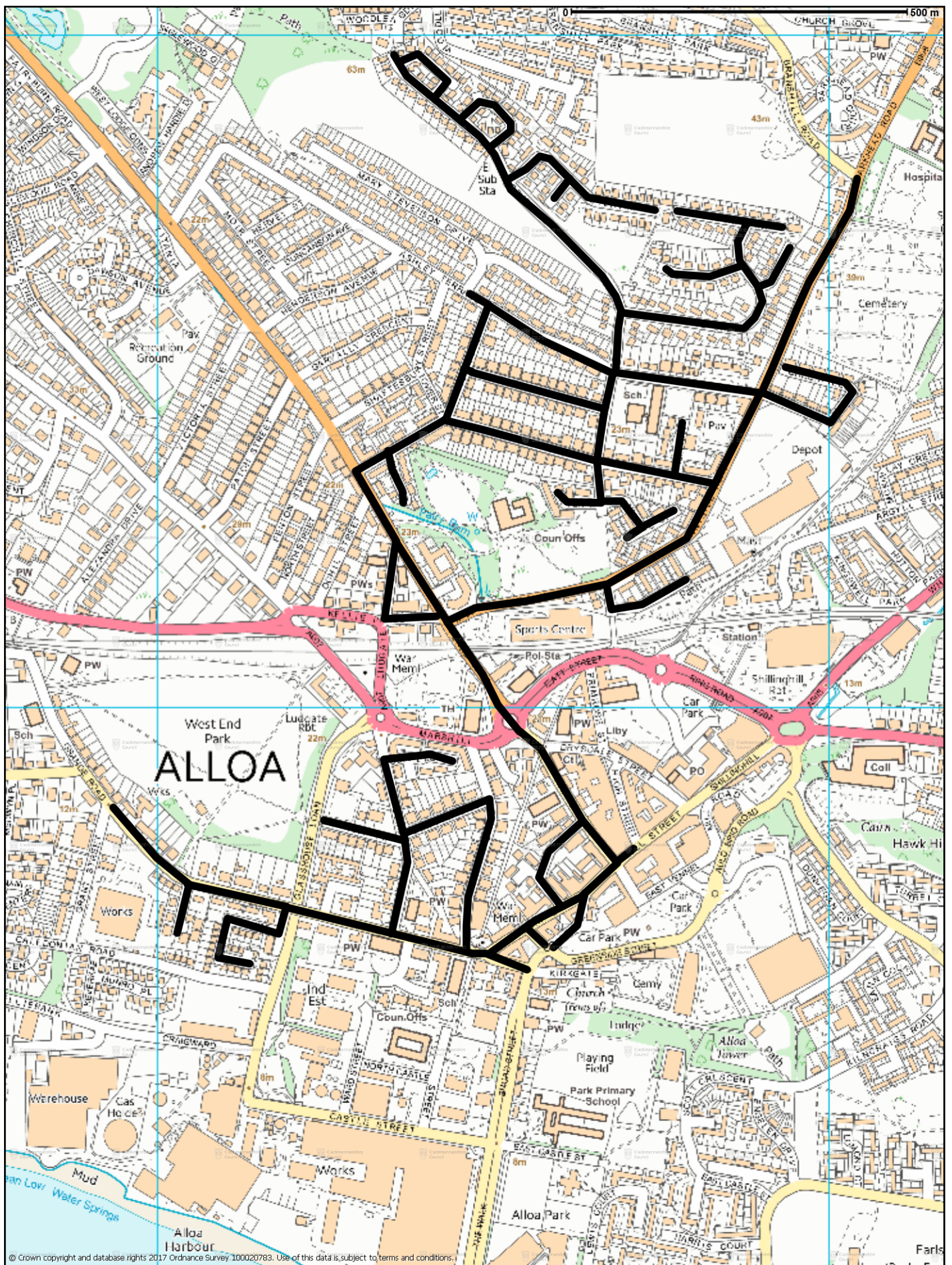
