**(VARIOUS STREETS, ALLOA)
(TEMPORARY ROAD CLOSURE) ORDER 2017**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Road Closure) Order 2017" and notwithstanding the date hereof shall come into operation at 0800 hours on 31st July 2017 and will remain in operation until 1530 hours on 11th August 2017.
2. The effect of this Order shall be to close to vehicles:-
The period from 0800 hours on Monday 31st July 2017 until 1530 hours on Friday 11th August 2017 or until works are completed whichever is soonest, on the section described in Schedule attached.
The temporary closure is necessary for resurfacing works.

The Clackmannanshire Council (Various Streets, Alloa) (Temporary Road Closure) Order 2017

The Council has made "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Road Closure) Order 2017", under the Road Traffic Regulation Act 1984 (as amended) on 29th May 2017: to close to vehicles at **Redwell Place, Alloa** – from its junction with A907 northwards until a point 50 metres or thereby south of Carse Terrace, a distance of 320 metres or thereby; **Norwood Crescent, Alloa** – from its junction with Redwell Place eastwards for a distance of 25 metres or thereby. The order runs from 0800 hours on Monday 31st July 2017 until 1530 hours on Friday 11th August 2017 or until works are completed whichever is soonest, and is necessary for resurfacing works. 
