



**(VARIOUS STREETS, TULLIBODY)
(TEMPORARY NO WAITING OR LOADING RESTRICTION) ORDER 2017**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Tullibody) (Temporary No Waiting or Loading Restriction) Order 2017" and notwithstanding the date hereof, Schedule shall come into operation at 0800 hours on Monday 31st July 2017 and will remain for 2 weeks.
2. The effect of this Order shall be that there will be no waiting at any time during:-

The period from 0800 hours on Monday 31st July 2017 for a period of 2 weeks or until works are completed whichever is soonest, on the section of roads described in Schedule. The temporary no waiting or loading is required for carriageway resurfacing. Diversion will be signed locally and residents affected will be advised.

The Council has made "The Clackmannanshire Council (Various Streets, Tullibody) (Temporary No Waiting or Loading Restriction) Order 2017, under the Road Traffic Regulation Act 1984 (as amended) on 5th July 2017: to where there will be no waiting or loading at **Craigeith View** (from its junction with Broomeknowe northwards for a distance of 130 metres or thereby); **Broomeknowe** (from its junction with The Braes westwards for a distance of 225 metres or thereby). The order runs from 0800 hours on Monday 31st July 2017 for a period of 2 weeks or until works are completed whichever is soonest. The works are required for carriageway resurfacing. Diversion will be signed locally and residents affected will be advised. 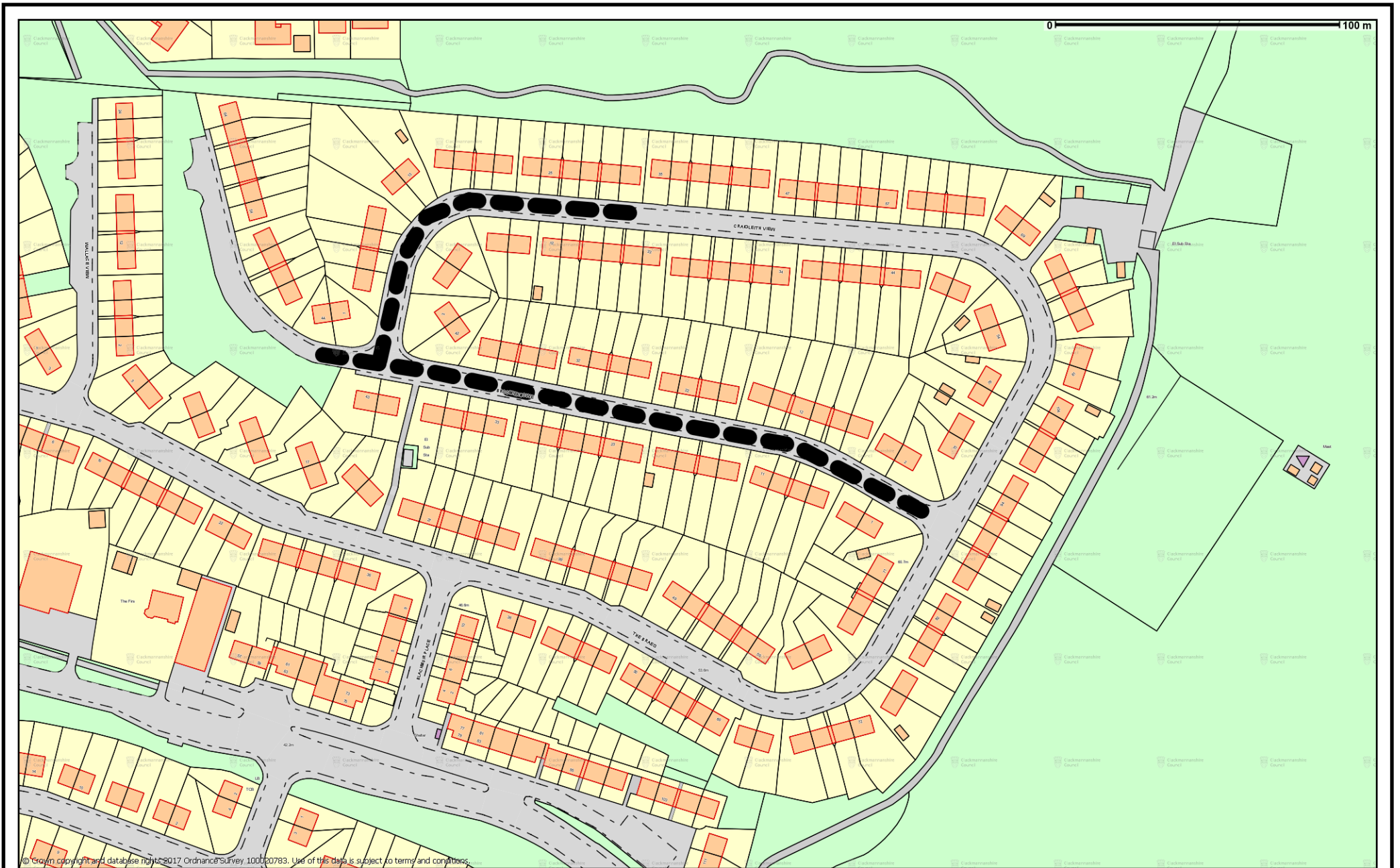
