

(BEDFORD PLACE, ALLOA) (TEMPORARY PARKING SUSPENSION) ORDER 2017

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (Bedford Place, Alloa) (Temporary Parking Suspension) Order 2017" and notwithstanding the date hereof shall come into operation at 0800 hours on Monday 11th September 2017 and will remain in operation for 10 days.
- 2. The effect of this Order shall be to suspend parking during:-The period from 0800 hours on Monday 11th September 2017 for a period of 10 days or until works are completed whichever is soonest, on the section described in the Schedule attached. The temporary parking suspension is required for safety reasons during maintenance work by MUS/BT.
