The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (C59 Kennet) (Temporary No Parking Restriction) Order 2017" and notwithstanding the date hereof shall come into operation at 0800 hours on Monday 18<sup>th</sup> September 2017 and will remain in operation for 2 weeks.
2. The effect of this Order shall be to suspend parking during:-  
The period from 0800 hours on Monday 18<sup>th</sup> September 2017 for a period of 2 weeks or until works are completed whichever is soonest, on the section described in the Schedule attached. The temporary no parking restriction is necessary for resurfacing works on the carriageway.

The Council has made "The Clackmannanshire Council (C59 Kennet) (Temporary No Parking Restriction) Order 2017", under the Road Traffic Regulation Act 1984 (as amended) on 23rd August 2017: to suspend parking at **C59 Kennet** - from 20 metres west of its junction with Mannan Drive eastwards for a distance of 560 metres or thereby. The order runs from 0800 hours on Monday 18<sup>th</sup> September 2017 for a period of 2 weeks or until works are completed whichever is soonest. The order is necessary for resurfacing works on the carriageway. 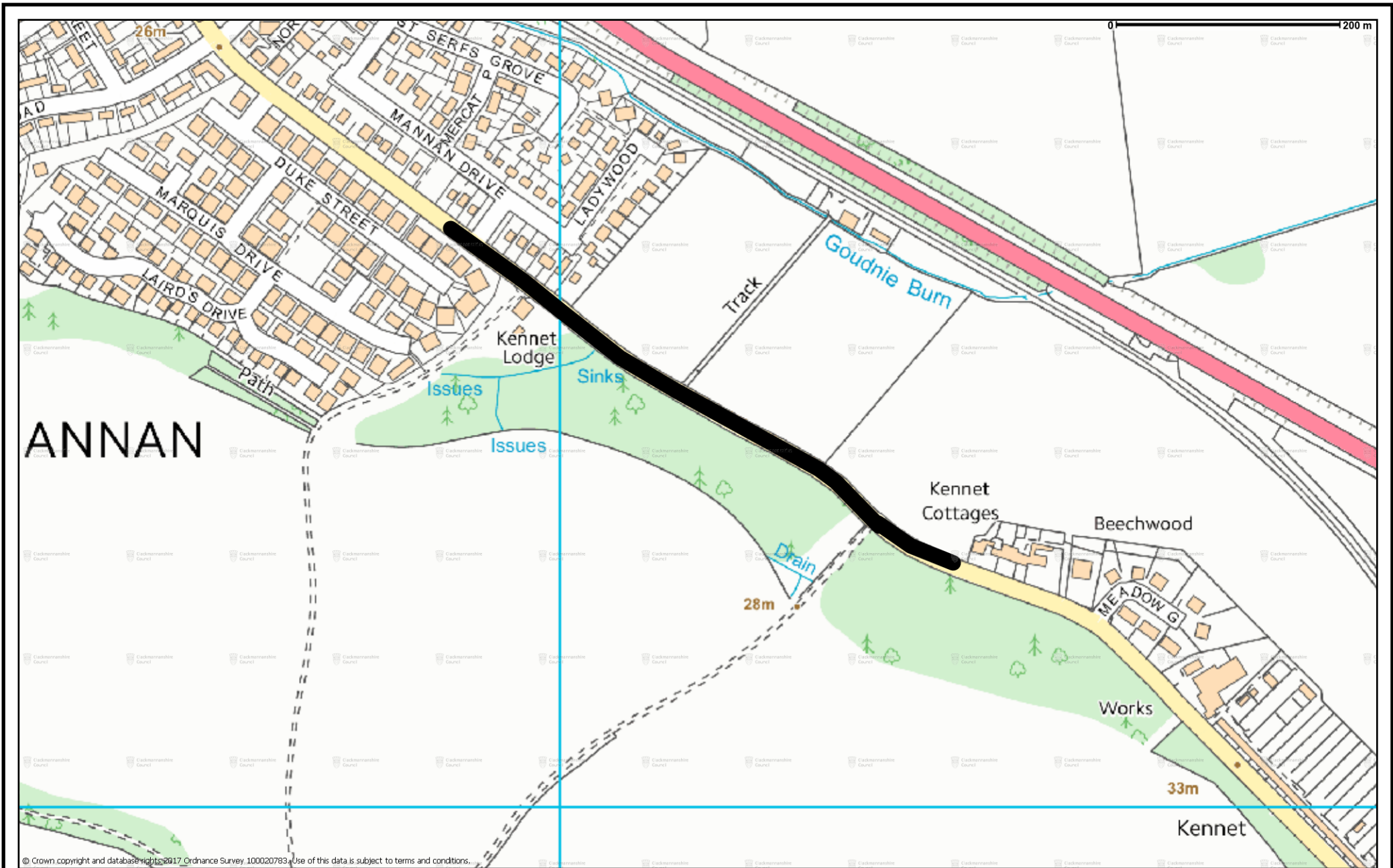
