

(SOUTHCROFT, ALVA) (TEMPORARY ROAD CLOSURE) ORDER 2017

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (Southcroft, Alva) (Temporary Road Closure) Order 2017" and notwithstanding the date hereof, Schedule shall come into operation at 0800 hours on Monday 25th September 2017 and will remain in operation for 2 weeks.
- 2. The effect of this Order shall be to close to vehicles:-

The period from 0800 hours on Monday 25th September 2017 for a period of 2 weeks or until works are completed whichever is soonest, on the section of roads described in Schedule. The temporary closure is necessary for resurfacing works to both footway and carriageway.

The Council has made "The Clackmannanshire Council (Southcroft, Alva) (Temporary Road Closure) Order 2017, under the Road Traffic Regulation Act 1984 (as amended) on 23rd August 2017: to close to vehicles the section of road at **Southcroft**, **Alva** (from its junction with A91 West Stirling Street southwards until its junction with West Johnstone Street, a distance of 100 metres or thereby), Diversion: Via West Stirling Street, Lower Queen Street, West Johnstone Street and vice versa. The order runs from 0800 hours on Monday 25th September 2017 for a period of 2 weeks or until works are completed whichever is soonest. The works are necessary for resurfacing works to both footway and carriageway.
