**(SOUTHCROFT, ALVA)
(TEMPORARY NO PARKING RESTRICTION) ORDER 2017**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Southcroft, Alva) (Temporary No Parking Restriction) Order 2017" and notwithstanding the date hereof shall come into operation at 0800 hours until 1600 hours each day from Monday 25th September 2017 and will remain in operation for 2 weeks.
2. The effect of this Order shall be to suspend parking during:-
The period from 0800 hours until 1600 hours each day from Monday 25th September 2017 for a period of 2 weeks or until works are completed whichever is soonest, on the section described in the Schedule attached. The temporary no parking restriction is necessary for resurfacing works to footway and carriageway. Residents can gain access thereafter at their own risk.

The Council has made "The Clackmannanshire Council (Southcroft, Alva) (Temporary No Parking Restriction) Order 2017", under the Road Traffic Regulation Act 1984 (as amended) on 23rd August 2017: to suspend parking at **Southcroft, Alva** - From its junction with A91 West Stirling Street southwards until its junction with West Johnstone Street, a distance of 100 metres or thereby. The order runs from 0800 hours until 1600 hours each day from Monday 25th September 2017 for a period of 2 weeks or until works are completed whichever is soonest. The order is necessary for resurfacing works to footway and carriageway. Residents can gain access thereafter at their own risk. 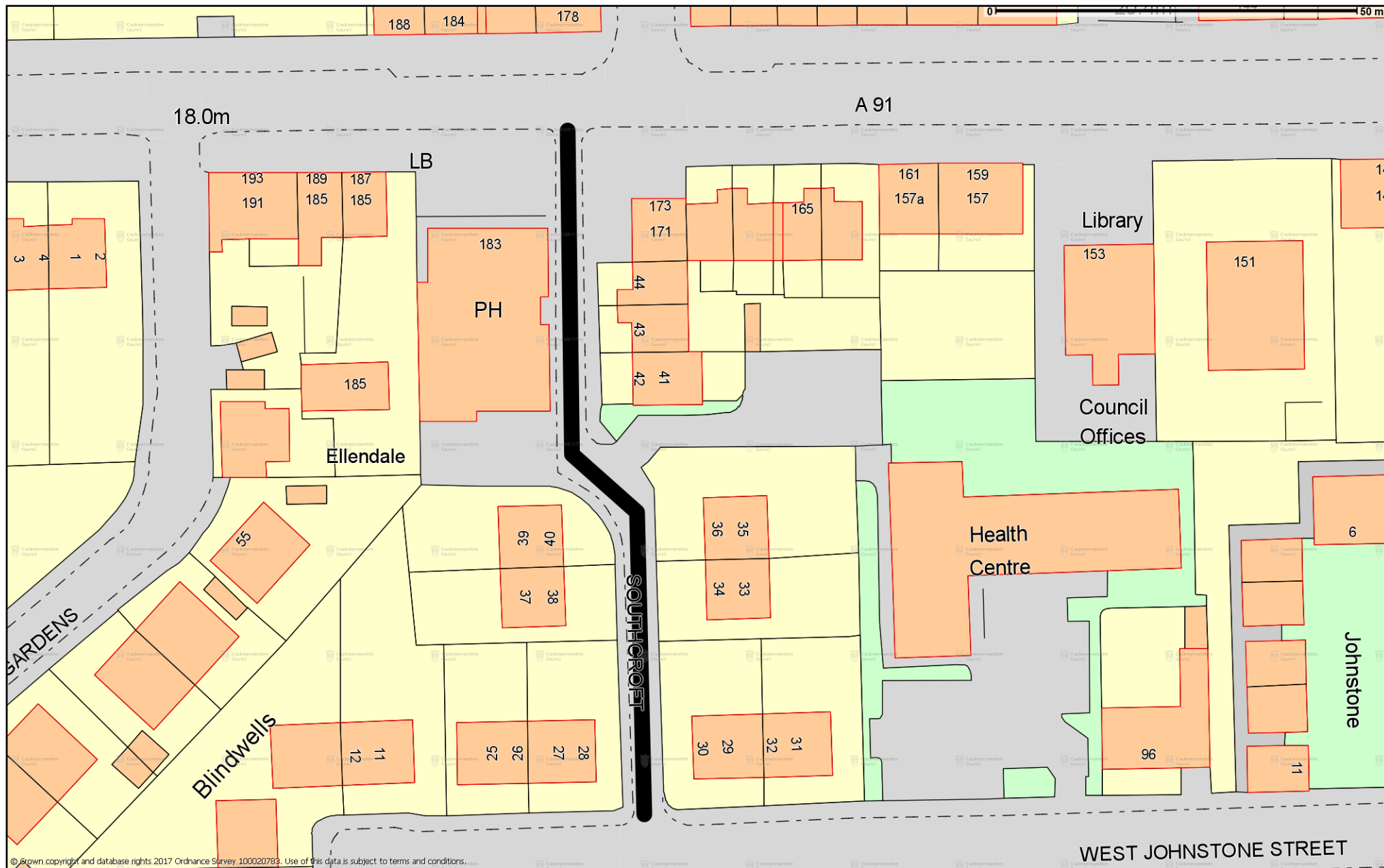
