This Order may be cited as "The Clackmannanshire Council (Main Street, Clackmannan) (Temporary Road Closure) Order 2017" and notwithstanding the date hereof, Schedule shall come into operation at 0800 hours on Sunday 26<sup>th</sup> November 2017 and will remain in operation until 1600 hours on that day.
2. The effect of this Order shall be to close to vehicles:-

The period from 0800 hours until 1600 on Sunday 26<sup>th</sup> November 2017, on the section of roads described in Schedule. The temporary closure is necessary to allow carriageway resurfacing works.

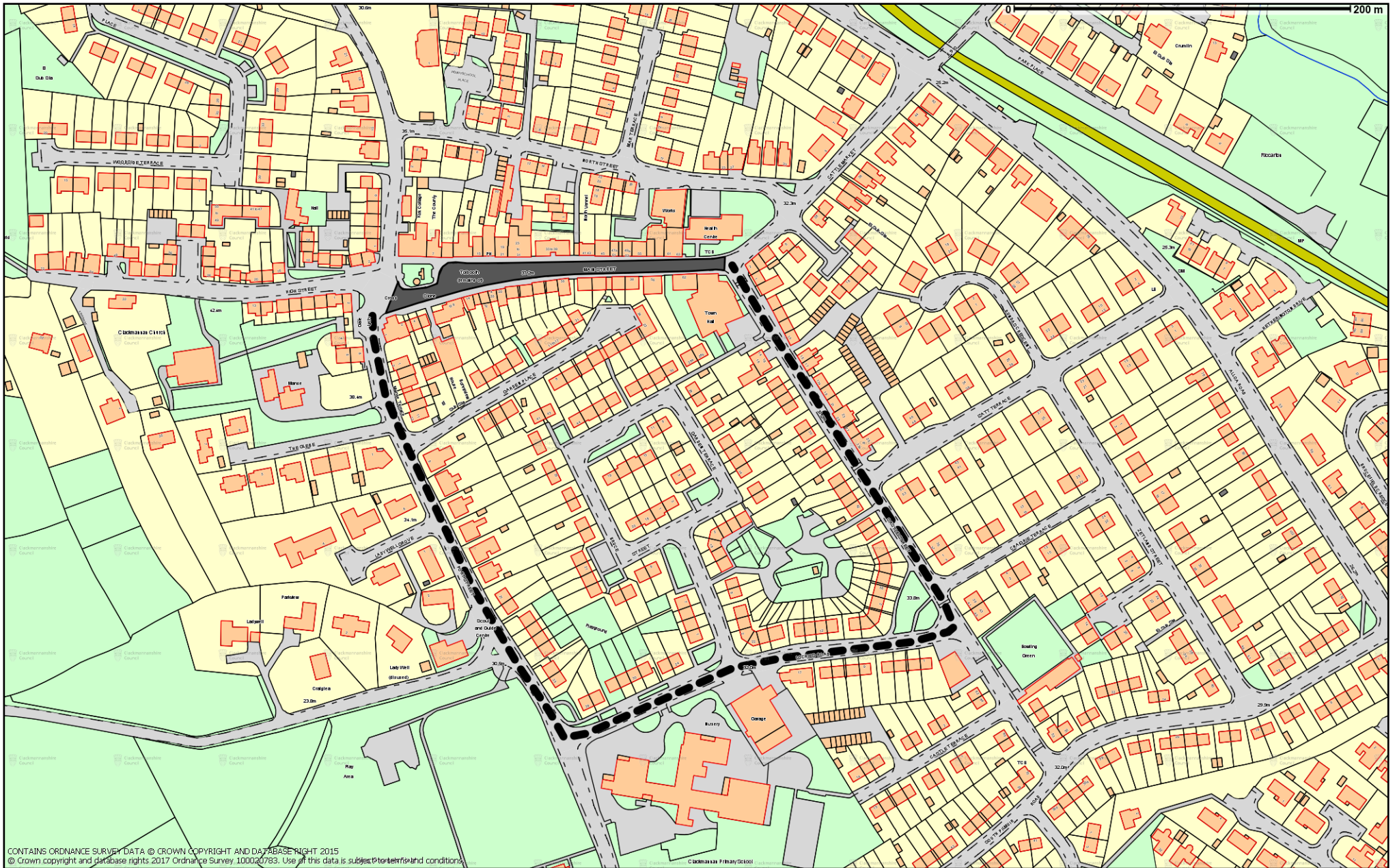
