

(NORTH STREET, CLACKMANNAN) (TEMPORARY SUSPENSION OF ONE WAY SYSTEM) ORDER 2017

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (North Street, Clackmannan) (Temporary Road Closure) Order 2017" and notwithstanding the date hereof shall come into operation at 0800 hours on Monday 27th November 2017 and will remain in operation for 8 weeks.
- The effect of this Order shall be to suspend one way traffic during:-2.

The period from 0800 hours on Monday 27th November 2017 for a period of 8 weeks or until works are complete whichever is soonest, on the sections of roads described in Schedule. The temporary one way suspension is required to provide safe access for larger vehicles to the old print works site on North Street during the building's demolition and allow for safe removal of debris from the site. All residents will be notified by letter.
