

### (MAIN STREET AND NORTH STREET, CLACKMANNAN) (EXPERIMENTAL ONE-WAY TRAFFIC) (PARTIAL REVOCATION) ORDER 2018

The CLACKMANNANSHIRE COUNCIL in exercise of the powers conferred on them by Sections 1(1), 2(1) to (3), 4(1), 9 and 10(2) of the Road Traffic Regulation Act 1984 and of all other powers enabling them in that behalf and after consultation with the Chief Constable in accordance with Parts III and IV of Schedule 9 of the said Act of 1984, hereby make the following Order:-

- 1. This Order may be cited as "The Clackmannanshire Council (Main Street and North Street, Clackmannan) (Experimental One-Way Traffic) (Partial Revocation) Order 2018" and shall come into operation on 11 May 2018.
- 2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. The Clackmannanshire Council (Main Street and North Street, Clackmannan) (Experimental One-Way Traffic) Order 2017 is hereby revoked in so far as it relates to North Street, Clackmannan.
- 4. The restriction imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Road Traffic Regulation Act 1984 or by or under any other enactment.
