

(B908 PARKWAY, ALLOA) (TEMPORARY ROAD CLOSURE) ORDER 2018

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (B908 Parkway, Alloa) (Temporary Road Closure) Order 2018" and notwithstanding the date hereof, Schedule shall come into operation at 0700 hours on Sunday 18th March 2018 and will remain in operation until 1400 hours on that day.
- 2. The effect of this Order shall be to close to vehicles:-

The period from 0700 hours until 1400 hours on Sunday 18th March 2018, on the section of roads described in Schedule. The temporary closure is necessary to facilitate the safe passage of participants in the Alloa Half Marathon

The Council has made "The Clackmannanshire Council (B908 Parkway, Alloa) (Temporary Road Closure) Order 2018, under the Road Traffic Regulation Act 1984 (as amended) on 11th January 2018: to close to vehicles the section of road at **B908 Parkway, Alloa** (from its junction with B9096 Mar Place northeastwards until its junction with Erskine Street, a distance of 240 metres or thereby), **Sunnyside Road, Alloa** (from its junction with Parkway northwards until its junction with Hill Place, a distance of 225 metres or thereby), (Alternative route: Via Ashley Terrace, Hill Place, Hill Street, Mar Place and vice versa). The order runs from 0700 hours until 1400 hours on Sunday 18th March 2018 and is necessary to facilitate the safe passage of participants in the Alloa Half Marathon at the start and finish lines.
