The period from 0700 hours until 1400 hours on Sunday 18<sup>th</sup> March 2018, on the section of roads described in Schedule. The temporary closure is necessary to facilitate the safe passage of participants in the Alloa Half Marathon

The order runs from 0700 hours until 1400 hours on Sunday 18<sup>th</sup> March 2018 and is necessary to facilitate the safe passage of participants in the Alloa Half Marathon at the start and finish lines. 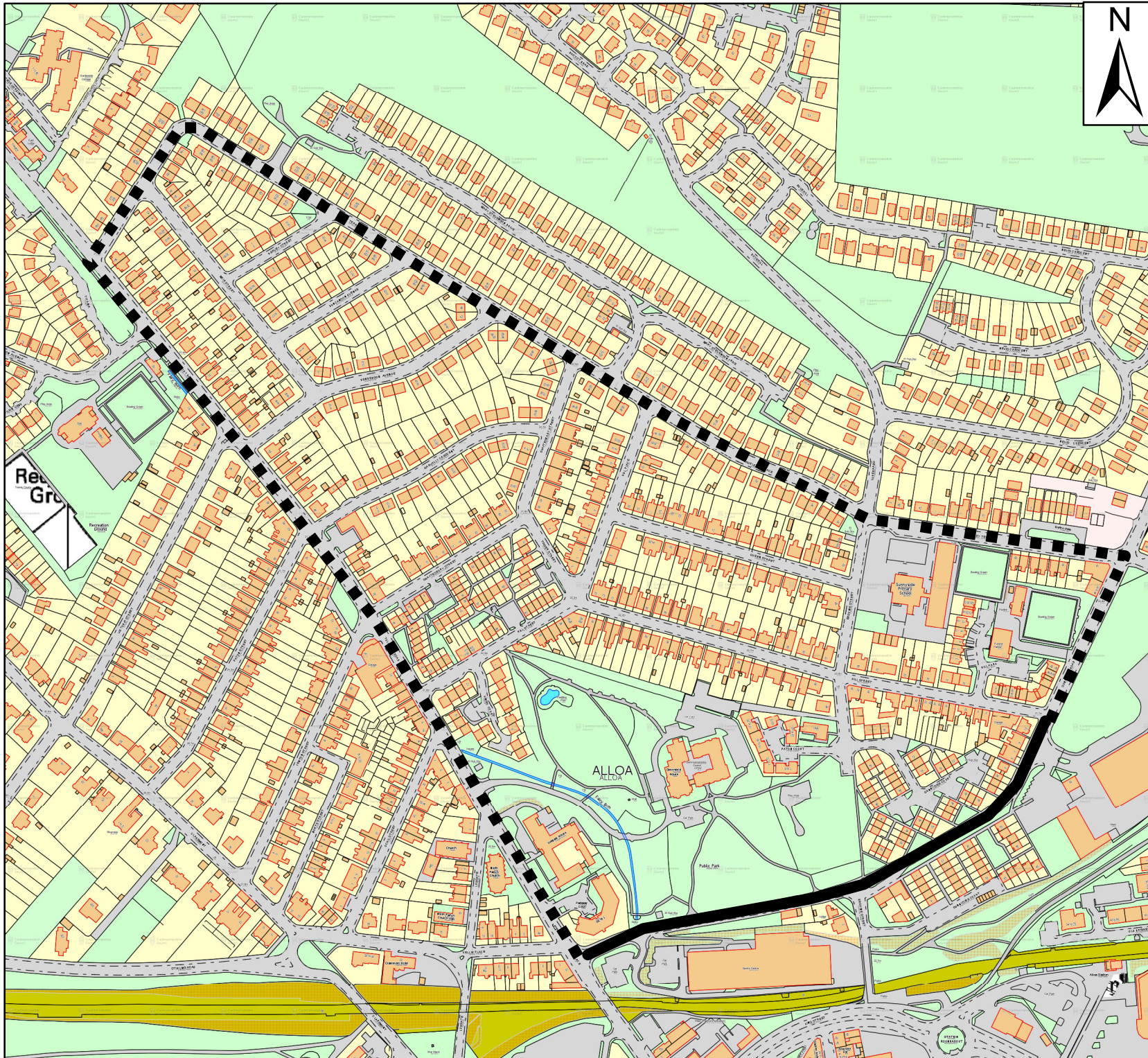
