



**(ALLOA TOWN CENTRE)
(ONE-WAY TRAFFIC) CONSOLIDATION ORDER 2018**

The CLACKMANNANSHIRE COUNCIL in exercise of the powers conferred on them by Section 1(1) and (2), 2(1) to (3) and 4(1) of the Road Traffic Regulation Act 1984 and of all other powers enabling them in that behalf and after consultation with the Chief Constable in accordance with Parts III and IV of Schedule 9 of the said Act of 1984, hereby make the following Order:-

1. This Order may be cited as "The Clackmannanshire Council (Alloa Town Centre) (One-Way Traffic) Consolidation Order 2018" and shall come into operation on the 11 May 2018.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The following orders are hereby revoked:
The Clackmannanshire Council (Alloa Town Centre) (One-Way) Order 2000
The Clackmannanshire Council (Alloa Town Centre) (One-Way) Order 2006
3. No person shall drive or cause or permit to be driven any vehicle on the lengths of roads specified in the Schedule to this Order other than in the direction specified in the said Schedule and shown on the plan annexed and signed as relative hereto.
4. Nothing in Article 3 of this Order shall apply to the driving of any small mechanical road cleansing vehicle being used in pursuance of statutory powers or duties.
5. Nothing in Article 3 of this order shall apply to a pedal cycle proceeding in either direction Candleriggs, Alloa (from East Vennel to Mill Street).

4. The restriction imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Road Traffic Regulation Act 1984 or by or under any other enactment.

The Council proposes to make the above Order under Section 1(1) and (2), 2(1) to (3) and 4(1) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984. Sections of roads over which one-way system will be applicable: **Burgh Mews, Alloa** (Permitted Direction – South to North from Bank Street to Mar Street); **Bank Street, Alloa** (Permitted Direction – West to East from Union Street to Mill Street); **Candleriggs, Alloa** (Permitted Direction – South to North from East Vennel to Mill Street); **Coalgate, Alloa** (Permitted Direction – South to North from West Vennel to Bank Street/Mill Street); **Drysdale Street, Alloa** (Permitted Direction – North to South from Mar Street to Shillinghill); **High Street, Alloa** (Permitted Direction – North to South from Drysdale Street to Mill Street); **Mar Street, Alloa** (Permitted Direction – South to North from Mill Street to Drysdale Street); **Mill Street, Alloa** (Permitted Direction – West to East from High Street to Shillinghill); **Mill Street, Alloa** (Permitted Direction – East to West from High Street to Mar Street); **Primrose Street, Alloa** (Permitted Direction – North to South from Ring Road (A907) to Drysdale Street); **Shillinghill, Alloa** (Permitted Direction West to East from Mill Street to Shillinghill Roundabout (A907)); and **Stripehead, Alloa** (Permitted Direction – East to West from Broad Street to Bedford Place/Bank Street). 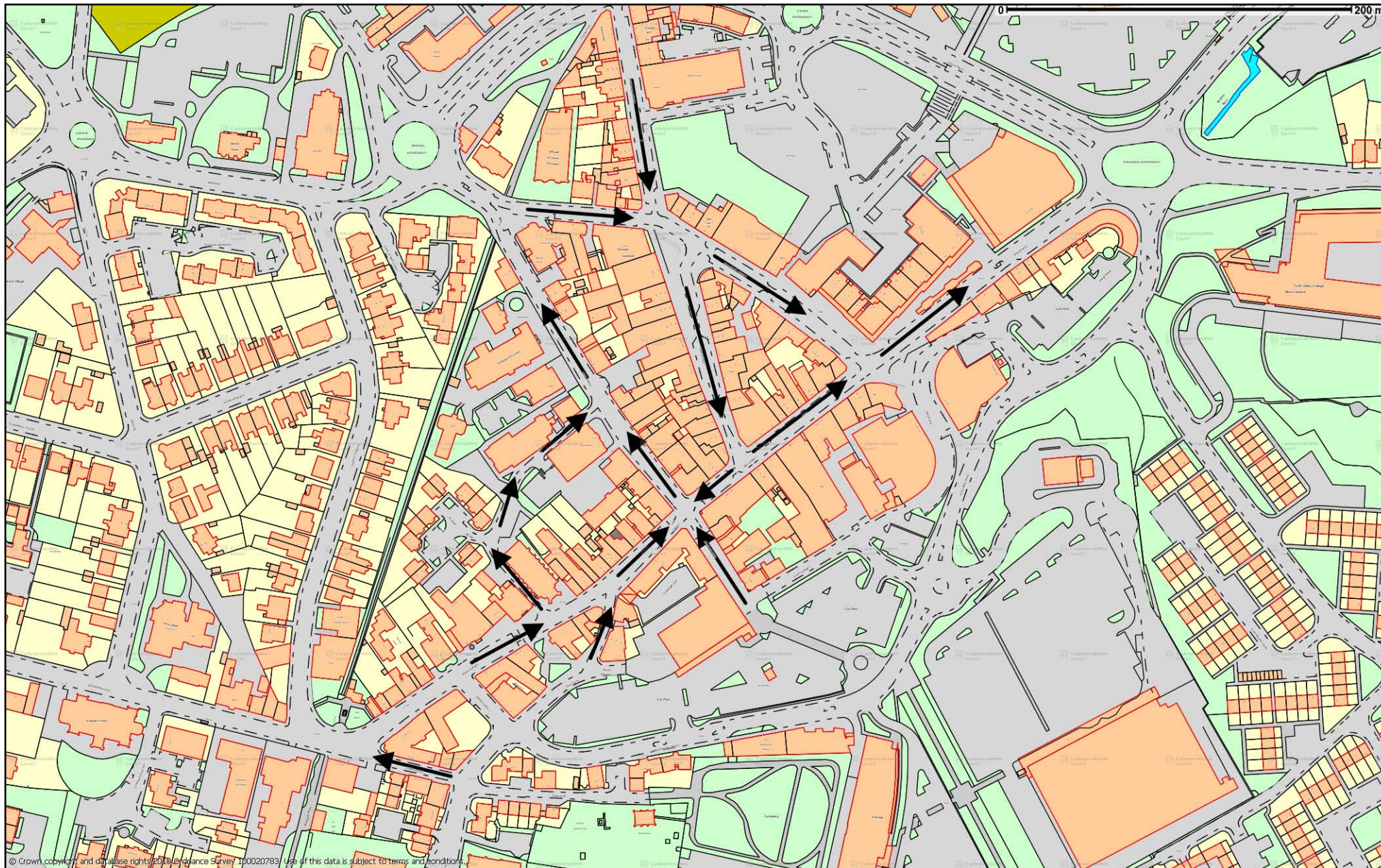
