



**(B908 PARKWAY, ALLOA)
(TEMPORARY NO WAITING OR LOADING RESTRICTION) ORDER 2018**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (B908 Parkway, Alloa) (Temporary No Waiting or Loading Restriction) Order 2018" and notwithstanding the date hereof, Schedule shall come into operation at 0700 hours on Sunday 3rd June 2018 and will remain operation until 1430 hours on that day.
2. The effect of this Order shall be that there will be no waiting at any time during:-

The period from 0700 hours until 1430 hours on Sunday 3rd June 2018, on the section of roads described in Schedule. The temporary no waiting or loading is necessary to facilitate the safe passage of participants in the Alloa Half Marathon.

The order runs from 0700 hours until 1430 hours on Sunday 3rd June 2018 and is necessary to facilitate the safe passage of participants in the Alloa Half Marathon. 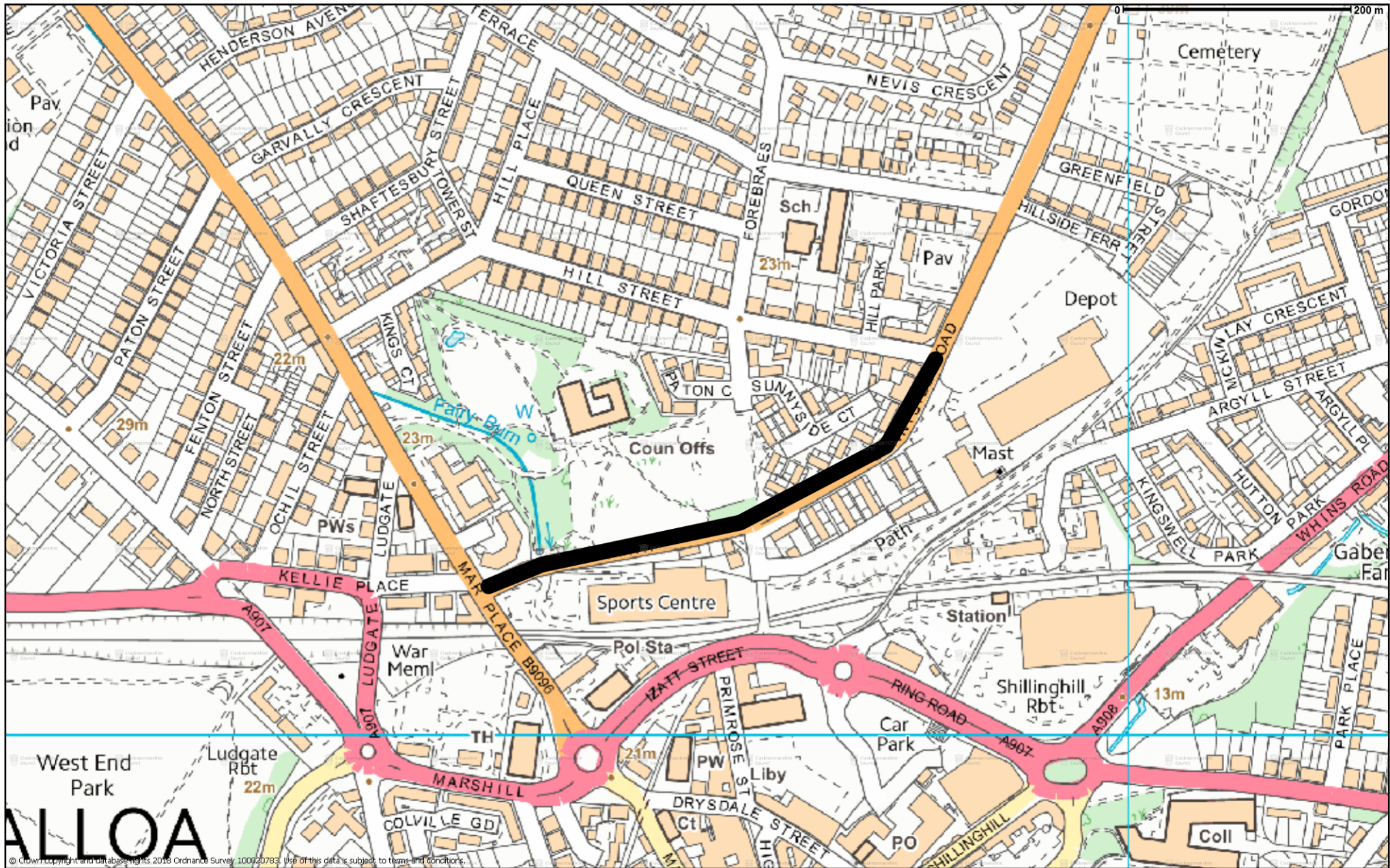
