



**(A908 FISHCROSS-DEVONSIDE)
(TEMPORARY ROAD CLOSURE) ORDER 2018**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (A908 Fishcross-Devonside) (Temporary Road Closure) Order 2018" and notwithstanding the date hereof, Schedule shall come into operation at 1000 hours on Sunday 3rd June 2018 and will remain in operation until 1230 hours on that day.
2. The effect of this Order shall be to close to vehicles:-

The period from 1000 hours until 1230 hours on Sunday 3rd June 2018, on the section of roads described in Schedule. The temporary closure is necessary to facilitate the safe passage of participants in the Alloa Half Marathon.

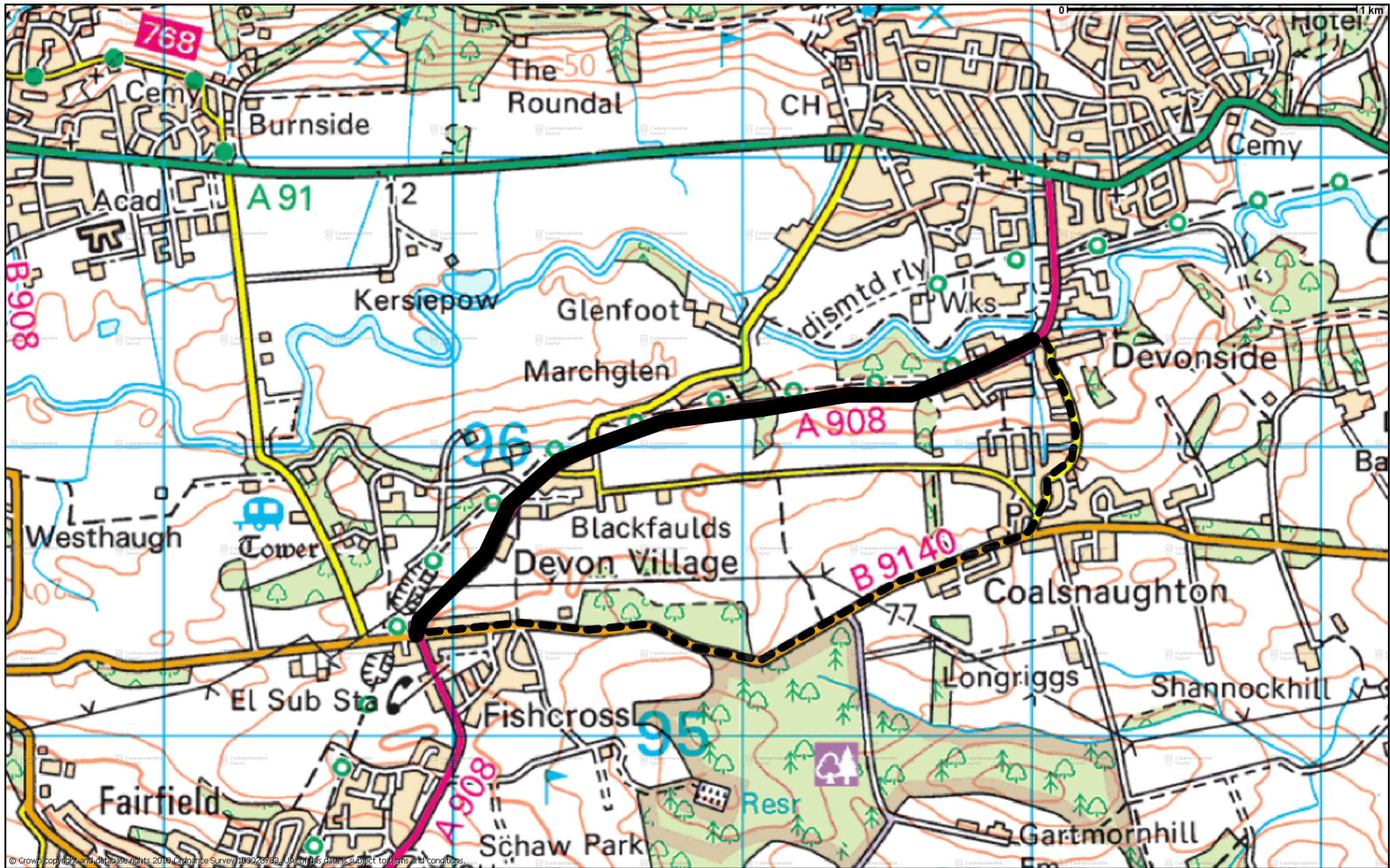
