

(VARIOUS STREETS, SAUCHIE) (TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2022

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (Various Streets, Sauchie) (Temporary Prohibition of Driving, Parking and Loading) Order 2022" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 15th August 2022 and will remain in operation until 1600 hours on Sunday 28h August 2022.
- 2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0800 hours on Monday 15th August 2022 until 1600 hours on Sunday 28th August 2022, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required for carriageway and footway resurfacing, safety of the workforce and members of the public.

The Council has made "The Clackmannanshire Council (Various Streets, Sauchie) (Temporary Prohibition of Driving, Parking and Loading) Order 2022, under the Road Traffic Regulation Act 1984 (as amended) on 20th July 2022: where there will be a temporary prohibition of driving, parking and loading at **Park Crescent, Sauchie** (from its junction with Braeside south westwards then north westwards then south westwards for a distance of 240 metres or thereby), **Braeside, Sauchie** (from its junction with Park Crescent south eastwards for a distance of 100 metres or thereby). The order runs from 0800 hours on Monday 15th August 2022 until 1600 hours on Sunday 28th August 2022. The works are required for carriageway and footway resurfacing, and safety of the workforce and members of the public. Full details are available on www.clacks.gov.uk
