



**(RICCARTON, CLACKMANNAN)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2024**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Riccarton, Clackmannan) (Temporary Prohibition of Driving, Parking and Loading) Order 2024" and notwithstanding the date hereof, the Schedule shall come into operation at 0900 hours until 1600 hours on Monday 18th March 2024 and Tuesday 19th March 2024.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0900 hours until 1600 hours on Monday 18th March 2024 and Tuesday 19th March 2024, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is necessary for removing trees from banking.

The Council has made "The Clackmannanshire Council (Riccarton, Clackmannan) (Temporary Prohibition of Driving, Parking and Loading) Order 2024, under the Road Traffic Regulation Act 1984 (as amended) on 20th February 2024: where there will be a temporary prohibition of driving, parking and loading at **Riccarton, Clackmannan** (From its junction with Burnside Crescent northwards until its junction with Cherryton Drive, a distance of 170 metres or thereby). Diversion via B910, A977, C59, Alloa Road, Riccarton and vice versa. The order runs from 0900 hours until 1600 hours on Monday 18th March 2024 and Tuesday 19th March 2024. 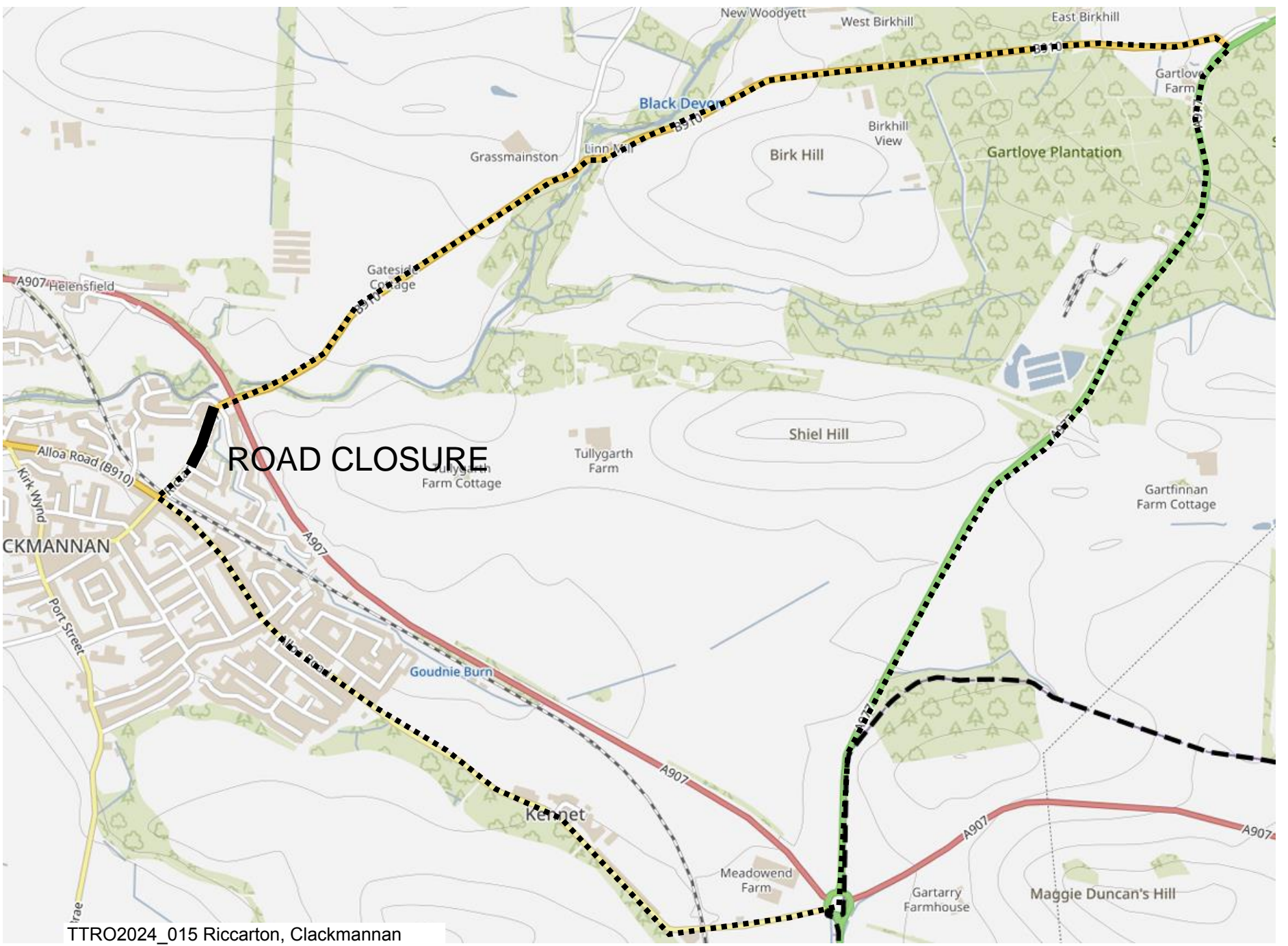
