

(A91 TILLICOULTRY TO MENSTRIE) (TEMPORARY ROAD CLOSURE) ORDER 2024

 (Temporary Road Closure) Order 2024" and notwithstanding the date hereof, the Schedule shall
 come into operation at 0900 hours on Sunday 17th March 2024 and will remain in operation until
 1230 hours on that day.
- 2. The effect of this Order shall be to close to vehicles:-

During the period from 0900 hours until 1230 hours on Sunday 17th March 2024, on the section of roads described in Schedule. The temporary closure is necessary to facilitate the safe passage of participants in the Alloa Half Marathon.
