

(B908 PARKWAY, ALLOA) (TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2024

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (B908 Parkway, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2024" and notwithstanding the date hereof, the Schedule shall come into operation at 0930 hours until 1800 hours on Tuesday 30th January 2024.
- 2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0930 hours until 1800 hours on Tuesday 30th January 2024, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required for Scottish Water ironwork repairs.

The Council has made "The Clackmannanshire Council (B908 Parkway, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2024, under the Road Traffic Regulation Act 1984 (as amended) on 3rd January 2024: where there will be a temporary prohibition of driving, parking and loading at **B908 Parkway, Alloa** (From a point 60 metres or thereby north of its junction with B9096 Mar Place, northwards until its junction with Sunnyside Court, a distance of 175 metres or thereby). Diversion Via B908 Sunnyside Road, B908 Parkhead Road, A908 Hallpark, A908 Whins Road, A907 King Street, B9096 Mar Place and vice versa. The order runs from 0930 hours until 1800 hours on Tuesday 30th January 2024. The temporary prohibition of driving, parking and loading is required for Scottish Water ironwork repairs. 
