



**(A91 DOLLAR TO POOL'O'MUCKHART)  
(TEMPORARY SPEED RESTRICTION) ORDER 2024**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (A91 Dollar to Pool'O'Muckhart) (Temporary Speed Restriction) Order 2024" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 1<sup>st</sup> April 2024 for a period of 18 months.
2. The effect of this Order shall be to reduce the speed to 40mph:

The period from 0800 hours on Monday 1<sup>st</sup> April 2024 for a period of 18 months, on the section of roads described in Schedule. The temporary speed restriction is required for road safety during the extraction of round wood timber.

The Council has made "The Clackmannanshire Council (A91 Dollar to Pool'O'Muckhart) (Temporary Speed Restriction) Order 2024, under the Road Traffic Regulation Act 1984 (as amended) on 6<sup>th</sup> March 2024: where there will be a temporary speed restriction of 40 mph at **A91 Dollar to Pool'O'Muckhart** (From a point 270 metres or thereby southwest of its junction with Upper Hillfoots Road, north eastwards for a distance of 400 metres or thereby). The order runs from 0800 hours on Monday 1<sup>st</sup> April 2024 for a period of 18 months. The temporary speed restriction is required for road safety during the extraction of round wood timber. 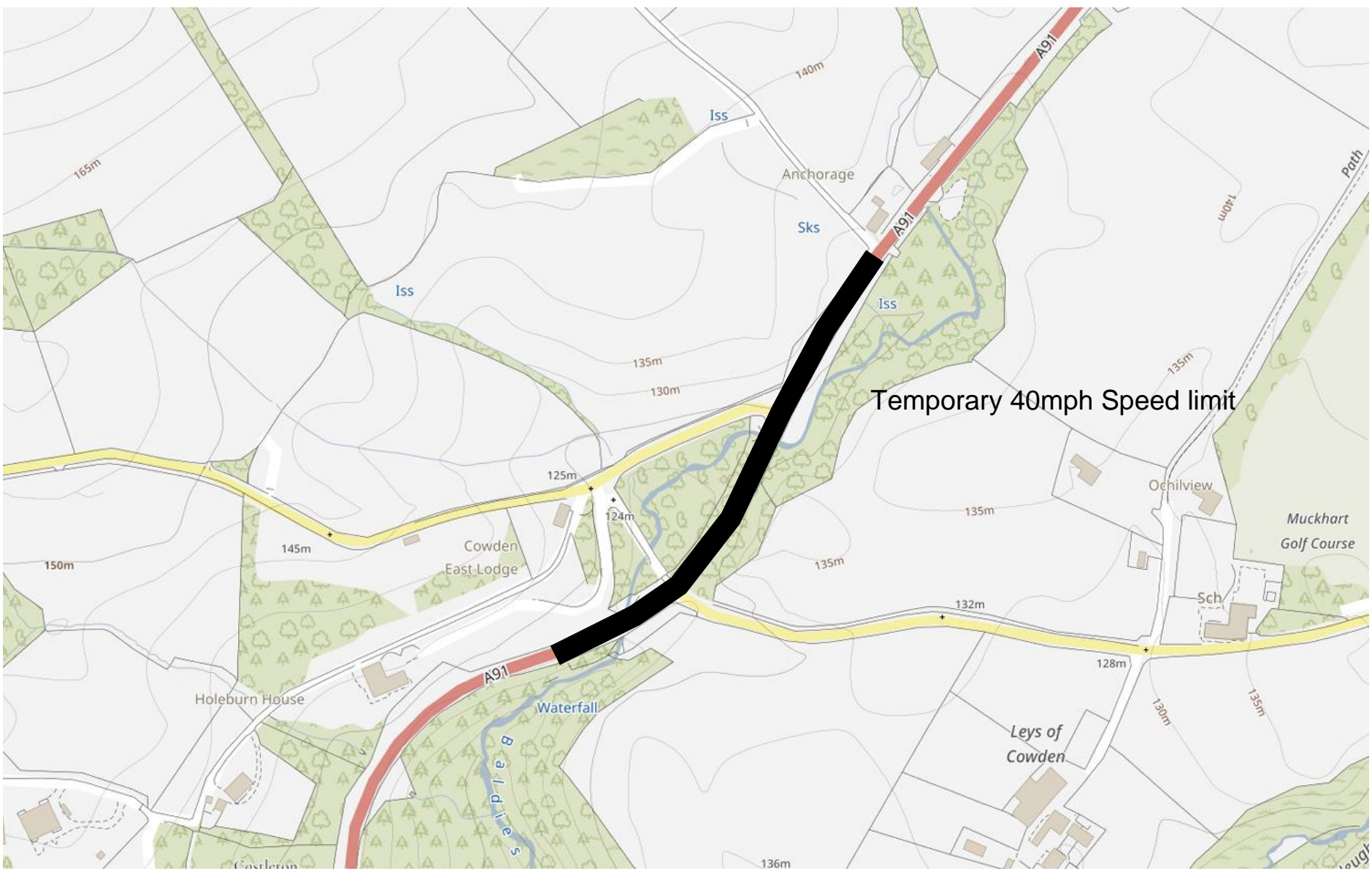
