(AMENDMENT) ORDER 2012**

The CLACKMANNANSHIRE COUNCIL in exercise of the powers conferred on them by Sections 1(1) and (2), 2(1) to (3), 4(2), 32(1) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and all other powers enabling them in that behalf, and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

1. This Order may be cited as "The Clackmannanshire Council (Clackmannan Road, Park Place, Balfour Street and Bruce Street, Alloa) (Waiting, Loading and Unloading Restrictions) (Amendment) Order 2012" and shall come into operation on 25 May 2012.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. This Order revokes Schedule 56 of "The Clackmannanshire Council (Clackmannan Road, Park Place, Balfour Street and Bruce Street, Alloa) (Prohibition of Waiting, Loading and Unloading Restrictions) (Amendment) Order 2004.
9. Insofar as any provision of this Order conflicts with a provision which is contained in an Order made or having effect as if made under the Act of 1984 and which imposes a restriction or prohibition on waiting by vehicles or grants an exemption from such restriction or prohibition then the effect of this Order shall prevail.
