(STOPPING-UP) ORDER 2013**

The Clackmannanshire Council in exercise of the powers conferred on them by Section 68(1) (a) of the Roads (Scotland) Act 1984, and of all other powers enabling them in that behalf, and having considered that the road specified in the Schedule to this order has become dangerous to the public, hereby make the following Order:-

1. This Order may be cited as “The Clackmannanshire Council (Straightbrae, Near Dollar) (Stopping-Up) Order 2013 and shall come into operation on 15th March 2013.
2. The effect of this Order shall be to stop-up the section of road as detailed in the schedule hereto for safety reasons as the road surface is damaged. The road will be removed from the list of adopted roads.
3. Where there is, immediately before the date on which the said road is stopped-up under this Order, any apparatus belonging to any statutory undertakers under, in, on, over, along or across this road for the purpose of carrying on their undertaking, the said statutory undertakers shall after the commencement of this Order continue to have all rights in respect of the said apparatus as they had immediately before that date.

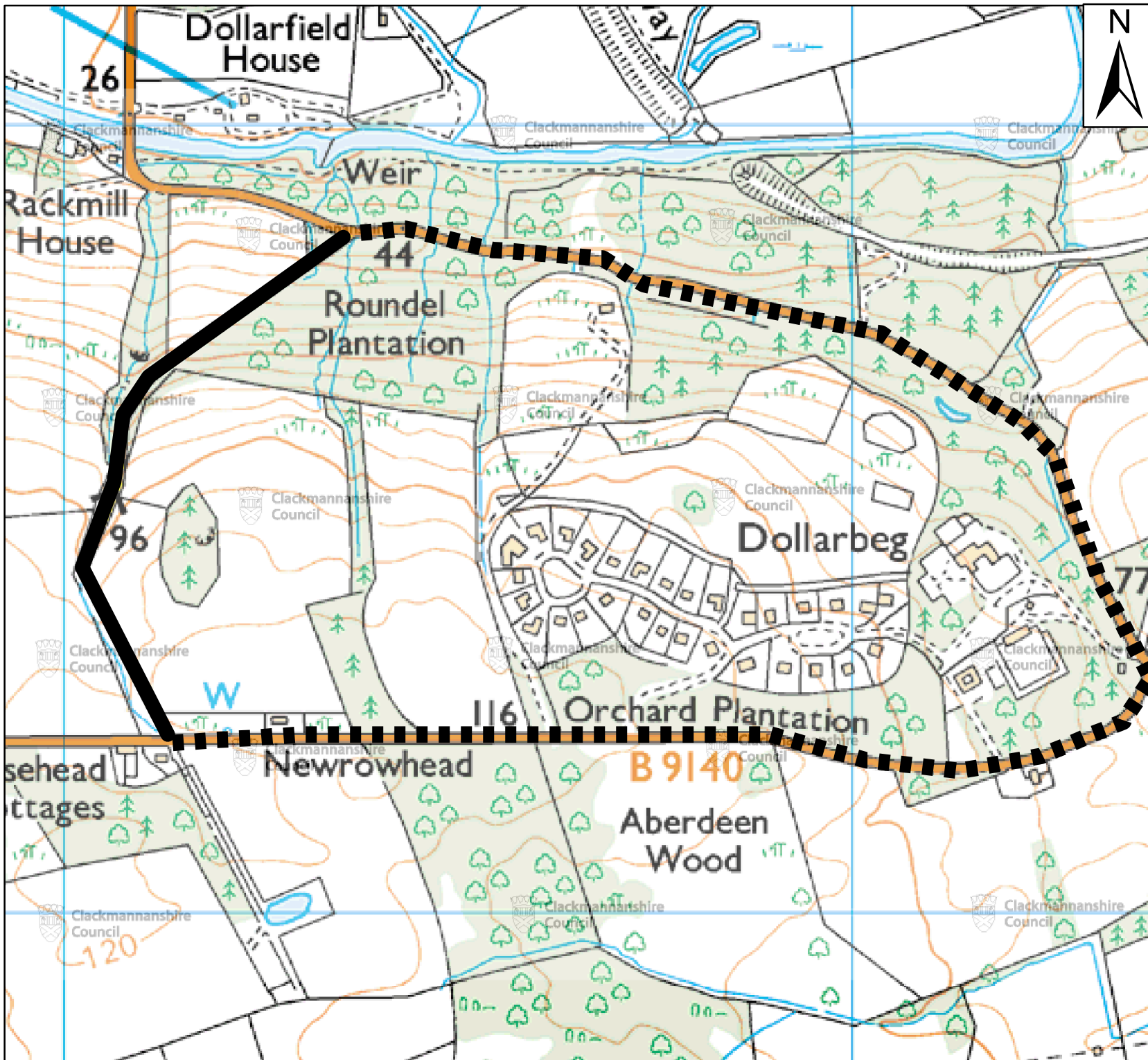
