

(VARIOUS STREETS, ALLOA) (TEMPORARY ROAD AND FOOTWAY CLOSURE) ORDER 2013

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Road and Footway Closure) Order 2013" and notwithstanding the date hereof shall come into operation on the 13th February 2013.
- 2. The effect of this Order shall be to close to vehicles and pedestrians:-The period from 0600 hours on Monday 25th February 2013 until 2400 hours on Wednesday 24th April 2013 on the section described in the Schedule attached. The temporary closure is necessary for safety during demolition works. Pedestrian access will be maintained where possible.

The Clackmannanshire Council (Various Streets, Alloa) (Temporary Road and Footway Closure) Order 2013

The Council has made "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Road and Footway Closure) Order 2013, under the Road Traffic Regulation Act 1984 (as amended) on 13th February 2013: to close to vehicles the section of road from **Primrose Place**, **Alloa**, (East Side): from its junction with Primrose Street eastwards for a distance of 48 metres or thereby. (Alternative Route: Via King Street, Primrose Street); and to close to pedestrians the section of footway from **Primrose Street**, **Alloa**, (East Side: From its junction with Primrose Place southwards for a distance of 40 metres or thereby). (Alternative Route: Opposite footway is available). The order runs from 0600 hours on Monday 25th February 2013 until 2400 hours on Wednesday 24th April 2013 and is necessary for safety during demolition works. Pedestrian access will be maintained where possible.
