

(LUDGATE, ALLOA) (TEMPORARY REVERSAL OF ONE WAY TRAFFIC) ORDER 2013

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (Ludgate, Alloa) (Temporary Reversal of One Way Traffic) Order 2013" and notwithstanding the date hereof shall come into operation on the 28th May 2013.
- 2. The effect of this Order shall be to reverse the one way traffic system during the period from 0800 hours on Tuesday 28th May 2013 until 1700 hours on Wednesday 29th May 2013 on the section described in the Schedule to allow access for residents and to help keep traffic moving while repairs are carried out to the church roof.
