- Your group should be properly constituted.
- You should be able to show evidence of community or individual benefit.
- Your project or group, should have clearly defined objectives.
- All applications should be clearly costed.

#### You may not be eligible if

 You or your group belongs to a national organisation which is currently funded by the Council.

- ➤ The service your group provides falls within the statutory remit of agencies other than the Council.
- Your group can be more appropriately funded through other grant schemes eg. Scottish Executive, Lotteries Board etc.

#### Priority will be given to

- Organisations which are of strategic importance to the Council.
- Locally based individuals, community groups, voluntary organisations and private organisations, which provide activities for the benefit of Clackmannanshire senior citizens.
- Individuals and organisations targeting senior citizens within the context of social development.

Decisions about grants are taken at the end of each calendar month. You will be informed of the outcome of your application.
