Note: Entitled two year olds will be eligible for 600 hours of early learning and childcare from the start of the term **following** their 2nd birthday; however, <u>only where</u> capacity allows they <u>may</u> be admitted to one of the listed Council nurseries on this form from the day of their 2nd birthday.

Children born **1st March 2016 – 29th February 2017** are eligible for the two year old entitlement from the start of term in August 2018 or the term following their 2nd birthday (providing they meet the necessary criteria). Children born **1st March 2017 – 31st August 2017will not** be eligible until August 2019.
