Brian asked that 8.7 of the minutes be amended to record that

These concerns were not accepted by the Forum. Brian commented that, with regard to land managers' advice not being followed, the Legal Advisor of the SRPBA advises that "in this event, any landowner/manager being pursued legally has the remedy to attach Council to any claim following the rejection of advice". The minutes were approved as amended by Councillor McLaren and seconded by Brian Poett. 3.0 Final Draft CPP - Cross boundary discrepancies 3.1 Path 32 Menstrie Map 2 Forum advice to the Council: Path 32 should stop at its junction with Path 175 and the westwards path from that point removed from the Plan. 3.2 Path 62 Tillicoultry Map 4 Forum advice to the Council: Path 62 should be extended northwards to the boundary with Perth and Kinross Council. 3.3 Path 165 Muckhart Map 8 Forum advice to the Council: Path 165 should be amended to accurately reflect the route that the path follows and also where it crosses the Council boundary. 3.4 Path 163 Muckhart Map 8 Forum advice to the Council: Path 168 should be extended southwards down the Balruddrie House road for ca 800m to the boundary with Perth and Kinross Council. 3.5 Path 176 Dollar Map 7 Forum advice to the Council: Path 176 should be extended

towards Braelangwell for ca 200m to the Council boundary.

4.0 Final Draft CPP - Formal objections	
4.1 Path 143 (Windy Edge Gap) Dollar Glen Map 7	
Forum advice to the Council: That the spur path leading off	
Path 143 to Windy Edge Gap should be added to the Plan.

Forum advice to the Council: That the eastern part of Path 119	
is removed from the Plan and replaced by a northwards link	
(suggested by the landowner) to Paths 120 and 121.	
4.3 Former railway Menstrie Map 2	
Forum advice to the Council: That the former railway should	
not be added to the Plan if, as per guidance, there is uncertainty	
over it being a usable path within 2 years of adoption.	
The importance of the route was recognised however, and it was	
agreed that the route should become a core path at some point in	
the future, but only when there is a path on the ground to follow.	
4.4 Path 138 Dollar Map 4	
Forum advice to the Council: That no adjustment is made to	
the Final Draft Plan and that the section referred to in the	
objection is not reinstated.	
4.5 Path 139 Dollar Map 7	
Forum advice to the Council: Path 139 is not considered to be	
essential to the network, although a strong case was made to the	
contrary in that it provides a significant and useful loop westwards	
from the town.	
It was noted that the possibility for a diversion exists below the	
house and farm.	
The Forum further recommended that improvements be made to	
Path 140.	
4.6 Path 50 Alva Map 3	
Forum advice to the Council: The Forum acknowledged the	
strategic value of the route, but felt that its condition was such	
that it should not be included in the Plan.
