<u>1.0 Apologies</u>	
1.1 Apologies were received from Drew Michie, Brian Poett, Mike Shepherd, Sir Robert Stewart (for first part of meeting) and Niall Urquhart	
<u>2.0 Approval of minutes of 28th May 2009</u>	
2.1 Colin T proposed that the minutes of 28th May 2009 were approved. This was seconded by David.	
<u>3.0 Matters arising</u>	
3.1 Woods In and Around Town Councillor McLaren reported	

<p>that the paths in Clackmannan Back Wood are serviceable, but that puddles do form in places during wet weather. He also advised that some of the bridges need to be replaced and that the paths showed some evidence of motor bike use.</p> <p>Alistair reported that the visit to look at the motorbike facility at Cardenden had not taken place because of difficulties in finding a suitable date.</p> <p>Gordon reported that he had visited Cambus and Alloa Woods with Jane Begg and that the paths were in need of some improvement. He also reported that jumps had been constructed in the woods by mountain bikers and that there was some litter and dumping.</p>	
<p>3.2 Ramblers Scotland Colin T and Gordon reported that Gordon would be the link with Ramblers Scotland.</p>	GD
<p>3.3 Partnership agreement Martin is due to arrange a meeting of the Working Group (comprising Drew, Alistair, David and Martin) appointed to review the current agreement.</p> <p>Martin reported that ill health has meant that Niall has not been able to prepare a paper highlighting how the Forum can advertise what it does to the wider public, but now that he is back at work, will address this in the near future.</p>	MD NU
<p>3.4 Inclusive Outdoor Access Network Martin reported that meetings have taken place between Julia Lawrie and Ian Newman (Fieldfare Trust) to ensure that the Ochils Landscape Partnership and the Inclusive Outdoor Access Network project do not duplicate each others work.</p>	
<p>3.5 Pegasus crossing Martin reported that Roads have said that they will complete the crossing in the near future.</p>

<p>4.0 Forum vacancies</p>	
<p>4.1 Enid Trevett of the Council for Voluntary Services Clackmannanshire has agreed to fill the Community Group vacancy on the Forum and was welcomed by Alistair.</p>	
<p>4.2 Chris Stark of the Forestry Commission has agreed to fill the vacancy in the Forum's Agencies and Advisory Group, and was also welcomed by Alistair.</p>	
<p>5.0 Forwarding of National Access Forum minutes</p>	
<p>5.1 Discussion took place on whether minutes from the National Access Forum meetings should be forwarded to members of the Clackmannanshire Access Forum. Colin W and James supported their circulation and it was agreed that future minutes will be forwarded on a trial basis.</p>	
<p>5.2 Martin reported that the annual joint meeting of the national</p>	

and local access forums is to be held in Inverness on 28th October. He went on to say that he would be attending and that a member of the Forum could also attend. Nobody else was able to attend, so it was agreed that Martin would e mail those members not at the meeting to see if they would like to represent Clackmannanshire at the meeting.	MD
5.3 Alistair suggested that Richard Cooke, Convenor of the National Access Forum be invited to the next meeting of the Clackmannanshire Access Forum and that Martin should contact him with the invitation.	MD
6.0 Signage advice	
6.1 Alistair thanked members for contributing to the advice given to the Council. Martin also thanked the Forum for its advice, and commented that it will be helpful when the core paths are signed.	
7.0 Any other business	
7.1 Ochils Landscape Partnership Alistair reported that he had received a letter from Julia Lawrie inviting a member of the Forum to become a join the Ochils Landscape Partnership sub-group for access. Gordon offered to represent the Forum on the sub-group.	GD
7.2 Gordon reported that he had encountered locked gates on the path up the west side of Silver Glen, and that the adjacent stiles were not easy to cross. The route is used by hill walkers to access Ben Ever and Ben Cleuch. Euan commented that self closing gates (located alongside field gates) have been installed on many other paths in Clackmannanshire and that these do work well in that they facilitate access whilst containing livestock. James reiterated that, pointing to some of the difficulties that can arise when people climb gates. Martin agreed to visit the site to look at the issue and to report back to the Forum at the next meeting.	MD

9.2 The discussion considered the type of use the path received and its importance for hill walkers was noted.

1.0 Core Paths Plan

The Strategic Environment Assessment Post-Adoption Statement has been written and submitted to the Scottish Government, the public notice of adoption of the Core Paths Plan has posted in the Alloa Advertiser and on the Council website, the Scottish Government has been advised of the adoption of the Plan and forwarded a copy of it, the web pages on the Core Paths Plan and SEA have been updated, and the Plan, together with the SEA, made available for inspection at the Council's Kilncraigs reception.

3.0 Climate Challenge Fund

The Climate Challenge Fund helps communities to put their own solutions for significant reduction of carbon emissions into action and is worth £27.4 million over three years (2008-11).

Improving paths around the Lornshill Academy to encourage pupils to walk/cycle, instead of being driven/taking other forms of motorised transport, would appear to meet the aims of the Fund, which is eligible to schools but not, ironically, to local authorities.

In light of the above, I have been liaising with the Academy over a possible bid by the school for Climate Challenge Funding to improve the surface of paths around the school.

4.0 Round The Forth route

The tenant farmer has recently indicated that he would be prepared to allow the cycle path to go through the tenanted ground and has held discussions with Diageo on the matter.

5.0 Walk Homecoming 2009

The following message was recently received from Alison Turnbull, Promoting Walking Coordinator, Ramblers Scotland:

Just a quick update on the Walk Homecoming 2009 project. Some of you may have seen the media reports regarding the financial situation of Ramblers Scotland and at the moment we are facing very severe budget cuts which may result in the closure of the Ramblers Scotland office. These budget cuts also include money set aside to fund the Walk Homecoming 2009 project.

As so much work has gone into the project already and we have already received an offer of grant funding for the project, we are now in the process of applying for further external grants to make up the funding shortfall and ensure that the project can continue. However, we will not know the outcome of these funding bids until early August. All design and printing work for the project will therefore have to be put on hold until this time.

For those to whom I have already sent out maps, please do continue to send them to me with marked routes, text descriptions and photos and I will hold onto them until such time as we are able to complete the project. Hopefully we will not have to wait too long for this to happen.

In the meantime, thank you all very much for your patience and I hope that we can start preparing leaflets for you before the summer is out.
