Minute of St Johns/Claremont Parent Council of 22nd February, 2011

Lisa Simpson welcomed attendees and introduced Lesley Robertson who gave a detailed powerpoint presentation in which she talked through the current position of St. Johns and Claremont Primary Schools and the proposed four options for merging the schools. Additional information was given in reference to questions asked at the Public Meeting held on 10 February 2010.

The meeting was then opened for questions and comments.

QUESTIONS RAISED / AREAS OF CONCERN:

 My preferred Option would be Option 4, but do have concerns in the size of the new school with a pupil count of 420. The projected population figures published in February state that there is an estimated 24% increase in the population by 2033, and children aged 0-15 a raise of 16.7%. I don't feel that we are planning for such an increase, and may have to resort to portacabins to accommodate such. Neil Wilson, Parent – Claremont

Lesley Roberston

The figures you refer to are Clackmannanshire wide, whilst there is growth in Clackmannanshire, its not looking that the bulk of house building will affect Alloa West. Based on the figures we have, the school should be big enough.

2. In the Local Plan there are currently 4 sites in the catchment area. I think that you should consider the type of housing within the catchment, for example there is a lot of flats proposed which tend to attract younger families.

I will go through the proposed development sites within the catchment area and apply the current formula for estimating the average amount of children per household to see the affect this may have.

3. Have you considered the amount of placements you may get in a brand new school, it may attract disabled children if it has better facilities.

As you know, people can request a place in any school but if the school is full there are no placements for people outwith the catchment.

4. Will the school be operating at capacity when it is built?

It will be sized-up so that it will be efficient, but whether it is full is hard to predict at the moment.

It would be helpful to understand what scope of flexibility is there in the size of the school. For example is it at 90% capacity?

420 pupils is the optimum, which lies between 85%–95% capacity, checked against the 2008 published figures.

6. I am somewhat confused, in reading the papers it seemed that the primary driver for the consultation was St Johns but throughout the meetings it seems to be the broader idea of St Johns and Claremont, which changes the dynamic. Is St Johns still the catalyst for this consultation?

We have been awarded £4.5million to assist in the construction of a new school, which was awarded as St Johns was in such a poor condition. The Scottish Futures Trust is awarding the funds but we have come forward with the proposal to combine the two schools which will share the same facilities. For a capital construction, it will benefit a larger amount of pupils.

7. The reason we have been awarded the money is to build a new St Johns. It seems peculiar that you have chosen to merge the schools which is not an optimal benefit for St Johns.

Merging the schools is optimal to benefit the most amount of pupils in Alloa West.

8. So the primary driver is for St Johns and Claremont, not just St Johns?

Lesley Robertson It is not the primary driver. Claremont suitability is currently a 'C' rating, St Johns is a 'D' rating. There is an opportunity to let as many young people as possible have the use of brand new facilities, but the reason the process was started was the condition of St Johns. If you would like to put your preferred option and comments onto the feedback form, comment on any of the options that you feel may not have been explored.

9. My understanding is that you are only consulting on the four options, isn't that correct? Where is the opportunity to formally consult on the other options?

Lesley Robertson

We are formally consulting on the four options. However, if feedback strongly suggests another option, this will be reported back to Elected Members and debated.

10. You have already constrained people to four options.

Lesley Robertson

We have chosen these four options as they seem most achievable, viable, affordable and has the best benefit for the most amount of children.

12. In regards to the size of the school, I have concerns. But I feel it is very much the staff of the school that make the standard. If a merge occurred, what would be the management of the school?

Lesley Robertson

There is no evidence in Scotland to suggest that the size of the school affects attainment. It is paramount that we have the best possible staff to deliver the best teaching and learning for the children. The actual size of the school at 420 pupils is not huge, for example Abercromby Primary has a current role of around 420 and is achieving very well; Tillicoultry Primary also had over 500 pupils and is highly regarded. In relation to the management of the school, I state from the minute of the Public Consultation "…education standard is no different to that of St Johns. It is about the quality of teaching staff, not the size of the school … Head Teacher appointment is concerned a competitive Scotland-wide interview would take place to ensure the correct candidate is selected."

13. If St Johns has been able to deteriorate and you have been awarded funding to rectify it, at what point do you decide that the best educational benefit would be to double the size of the school?

As St Johns is a listed building, there are some difficulties in keeping the building maintained. The condition and suitability of St Johns is a level 'D'; Claremont suitability is a level 'C' and the original business case sought to maximise the benefits for people in Alloa West.

14. I think you have made your decision based on the fact that the Council cannot afford the upkeep of two schools and in combining two, it will be less of a cost. Any of the options have an equal amount of educational benefit. My concern is the claim you make that educational benefit is at the core of the consultation, as it seems to be financial.

I disagree with the comment that the options have the same educational benefit. There are advantages and disadvantages for all the options.

15. I hope that when this is voted on the educational benefit is at the core of the decision, not that the Council has some funding and would like to spread it as thinly as they possibly can to cover any gaps they have in their Estate.

There are two Elected Members present tonight, who will have noted the comment. As Tax Payers you would expect Officers of the Council to be as prudent as they can with the funding awarded to deliver the best education service.

16. Can you quantify the educational benefit that will be lost in building a new merged school than a new St Johns School?

The benefits of a new build single school and a new build merged school are broadly the same. A merged school will allow other children to access the facilities. There are benefits for staff coming together and young people having better social skills in mixing up groups.

In Scottish terms the proposed merged school is a large middle-sized school, it is not huge.

18. What about in terms of Alloa West?

Lesley Robertson

In Clackmannanshire terms, it would be one of the biggest primary schools in the county. But it would not be the biggest school; Alva and Tillicoultry are bigger and Abercromby is currently at that size and is projected to become larger.

19. There have been a number of International studies that show that as a school becomes larger boys tend to attain less well. The money that has been allocated to this project is because of St Johns, if Claremont requires funding then it should be looked at as well. We should be looking at what is best educationally for the children.

Lesley Robertson

I agree that the best option should be chosen for the education of the children. If the decision is to have a single build St Johns, Claremont would continue to be maintained under the rolling programme of maintenance the Council hold. In relation to attainment in boys, current research in the McKenzie report has looked at high performing schools and it is the quality of teaching that makes the difference, not the size of the school.

20. We were previously given attainment levels in each subject from Tillicoultry, Abercromby, St Johns and Claremont. The attainment levels in the two larger schools were far above St Johns and Claremont, so the argument that a larger school has less attainment does not agree with the evidence shown. We seem to be hearing that 200 Claremont pupils should not get the best facilities that can be available at the moment.

21. All the children should get the best, but the primary drive for funding and this consultation was St Johns but now it seems to be for the Alloa West Community. But I quite agree that all children should get the best opportunities to move forward.

The primary driver was stimulated by St Johns, Eileen can go further into the original Business Case. **Eileen Turnbull**

The basic Business Case from last years consultation was a combination of both St Johns and Claremont.
22. Comments were made in relation to attainment levels, this was taken from one year group and I feel that if you look at previous year groups and levels since, the attainment will be very different. Can I also add from a personal point of view, I don't feel that we can properly review the best option when the feedback you have presented shows one school moving to a new build, not two schools merging to a new build. We should have sufficient evidence and would value this as a teacher in one of the affected schools. *Kate Paterson, Teacher– St Johns*

We have noted your comment but there will be an opportunity for Teachers to consult.

- 23. On the technical report it states that there are current maintenance problems in Claremont, which might not have a direct impact on St Johns but I think that the ongoing maintenance costs would come out of the general education finances.
- 24. A few points that I raised at the Public Meeting, which I am still not clear about, in regards to class sizes. The potential size of the school [in housing development terms] if it is become bigger, would it still be the case that you can build additional extensions instead of using porta cabins?

When you build a school which is intended for 400-420 children, you do not normally design the building with the intention to extend in the future. Schools are built in streams i.e. a one stream school, or two stream school.

25. This worries me as last year there was a potential to build extension. In the original proposal there was 23 classrooms and 4 other rooms now there is 16 classrooms and 4 other rooms. The class sizes last year were stated to have P1-P3 classes no larger than 18 pupils, yet the proposed figure for 2012 state P1 would be no larger than 18 and P2-P3 would be 24 pupils. So again last year and this year the figures are different. I understand the Government guidelines are to be no larger than 18 but the legality is that they are no larger than 26.

The figures for P1 is 25 pupils, P2 and P3 is 30 pupils.

	Eileen Turnbull Apologies if this was not clear in your previous answer, the indicative 3500m ² that were allocated to the school are based on 15 classrooms of 60m ² and 3 smaller classrooms of 40m ² , in terms of the costed proposals in the technical options, these are not fixed number of classrooms. This is purely for costing purposes, there is no intention of cutting the classrooms.
27.	What happens if we do have a potential housing developments which could increase the Alloa West population? This worries me if we increase the class sizes in conjunction with the educational benefit. <i>Gavin Maxwell, Parent – St Johns</i>
	Lesley Robertson The figures that were shown were indicative for costing purposes. The Government policy on class sizes that cap P1 at a maximum 25 pupils will be legislated from August 2011. We will continue to keep the pupil teacher ratio to 1:18 as far as possible. For example, if the catchment area for a year group is 19, you suggest you take one child and place them in a composite class – being rigid on class numbers can be a disadvantage. It's the quality of the educational experience rather than class sizes that make the difference.
28.	The Government are taking these steps as it has shown it is beneficial to make the class sizes smaller. A smaller group is better than a large group. Jacqui Monk, Parent – St Johns
	 Lesley Robertson You can take 25 children with an excellent teacher and 18 with a good teacher, it is the quality of teaching that makes the difference. Stephen Crawford We have a unique opportunity to build a school, we will design to accommodate class sizes of 18 pupils.
29.	I don't see where there is a benefit with teachers coming together, as far as I understand teachers should be at the same level. Gavin Maxwell, Parent – St Johns
	Lesley Robertson A greater mix of staff can create a broader mix of skills and interests which can encourage children. There is a richer blend of opportunities, for example music and drama.
30.	How do you expect to filter that specific skill through 400 children? Gavin Maxwell, Parent – St Johns
31.	Lesley Robertson You can afford that as an after school opportunity and can encourage staff to develop and deliver different skills. You need a figurehead in any organisation or school, the quality of education ultimately comes from the
•	Head Teacher. You stated at the last meeting that the interview would be Scotland-wide, but in the papers it states that "the proposal would mean that one Head Teacher post would become redundant, if both of the current post holders expressed an interest in the post of a Head Teacher in a merged school appointment would be made by competitive interview". In my understanding that implies that only the current Head Teachers could be selected, not a Scotland-wide interview as you last stated. <i>Gavin Maxwell, Parent – St Johns</i>
	Lesley Robertson I have stated the Chief Executive answer from the minute of the previous public consultation.
32.	So this overrides the proposal? Gavin Maxwell, Parent – St Johns
	Lesley Robertson As far as I am concerned it does, yes.
33.	I do not see why you have it in the proposal in the first place, not everyone knows where to find the minute, they are going to assume the proposal is correct. <i>Gavin Maxwell, Parent – St Johns</i>
	Lesley Robertson I think it is open to your interpretation of a competitive interview.
34.	The Head Teacher and the staffing of a school is of great importance to the educational benefit of my three children when this proposal is concluded.
	Gavin Maxwell, Parent – St Johns Lesley Robertson I don't disagree that leadership is very important. Currently parents are heavily involved in the engagement of a new Head Teacher and I do not see why this would change. Lisa Simpson
35.	It would be very helpful if you could articulate your comments and questions on the consultation feedback. There was a few comments you have made in regards to the coming together of teachers and how they
	would be managed. It sounds like a secondary school structure, why are you phasing this at primary school level?

In the recent winter, St Johns found it very difficult and a significant amount of the Head Teacher's time could have been better spent looking after the children, rather than the building.

44. The price of building a new St Johns and combined school does not seem to be a great deal in difference. But when you look at the value of Claremont being at £750,000, I think if you can clear this off your bill already that's a benefit to the Council.

Councillor Holden expressed his concerns in regards to the question of whether or not the lack of information on unsecured finances on one of the options deems the consultation invalid, and requested a quick response. He expressed his thanks to the Parent Council for their questions and comments.
