From May 2007 special responsibility allowances have been paid to the Leader of the Council, the Provost and 8 elected members with significant responsibility. The rates are set at levels recommended by the Scottish Local Authorities Remuneration Committee. Payments are subject to income

Travel and Subsistence: Payments are paid at rates determined by Scottish Government.

Telephone Allowances: The element of Councillors' telephone expenses that relates directly to their duties as a Councillor is reimbursed.

Official Council Car: The costs relating to SL1 being used as the official car are shown in column (F) . The Council car is not used for purposes other than official
